I pulled up to her and asked if she could move up to the parking lot so she would not get hit and she became very verbally abusive. Due to her state of mind I called for an ambulance but prior to their arrival she got angry and began to take off walking down the middle of Covert Ave. I walked behind her reaching to grab her to get her to stop and at that time she tossed a cup of water on me and had to be handcuffed. AMR did arrive and were able to get her to calm down. She told them her name and we were able to look up her address. She refused to allow me to give her a ride home but did accept from another Officer and was taken home. I did speak with her sister who stated Sylvia is bipolar and that she has been trying to get her help. She stated she has talked to everyone but no one seems to be able to do anything.
