# TAX PROBLEMS PLAGUE RIVER HOUSE

The River House has been a main topic of conversation for Evansville residents for several years. In recent days, local residents have seen the dilapidated state of the former iconic building. In further research, the property's condition may be the least of the owner's problems.

According to Vanderburgh County Treasurer Rick Davis, The River House is owned by Van Natta Holdings VII LLC of Seymour, Ind., and is comprised of two parcels. He also said the property currently has an outstanding tax debt of \$14, 503.71 as of June 30, 2009, just to stay off the tax sale list. As the deadline came and went, the River House has not made a single dollar towards the tax debt.

Davis then spelled out the three-step process that has varying amounts of money owed depending on the time of their payment.

"The minimum amount owed today for one parcel is \$7,313.45 and \$7,190.26 for the other parcel, totaling \$14,503.71 in order to stay off of the tax sale list. Those

amounts include everything that was owed in Spring 2008 plus penalties and interest. The deadline for that total to be paid to the Vanderburgh County Treasurer's Office is June 30, 2009. After today, our office will compile the list of tax sale properties. Once that compilation is complete, we will officially certify the tax sale list. Between today's deadline and the actual certification, which may take a few days, the River House can still make the minimum payment in order to stay off of the certified tax sale list," said Davis.

But once that certified list is compiled, the River House will then owe a minimum \$35,140.32 on one parcel and \$59,560.41 on the other parcel, which is a total of \$94,700.73, and is due before Sept. 14, which is the tax sale this year. The total includes all taxes, penalties and interest from last spring, last fall, and this spring.

Once the tax sale occurs on Sept. 14, 2009, the MINI-MUM BID on the first parcel is \$54,789 and \$101,615.95, which includes all prior taxes plus the fall amount. The River House has one year to pay those two sums in order to redeem their property. The winning bidder of both parcels at the Sept. 14 tax sale will receive their money back plus interest.

According to Vanderburgh County Assessor Jonathan Weaver, the first parcel, located at 127 SE First Street, assessed for \$443,500 in 2007 to be paid in 2008, and \$3,177,600 in 2008 pay 2009. The second parcel, which is located at 207 SE First St., assessed for \$451,000 in 2007 to be paid in 2008, and \$1,484,600 in 2008 to be paid 2009.

The Health Department also presented its report this week. The recommendations said the property violated

# Mayor Requests Local Homestead Tax Credit Renewal in 2010

(EVANSVILLE, IN) – Mayor Jonathan Weinzapfel announced today that a resolution has been filed with the Evansville City Clerk to establish the full 8% Local Homestead Tax Credit in 2010.

"With this action today, I am following through with my promise to the people of Evansville to ask City Council to reinstate the full Local Homestead Tax Credit for 2010. We estimate that amount to be about \$3.1 million based on 2008 figures," said Mayor Jonathan Weinzapfel. "In the days and weeks ahead, my administration will be taking a critical look at the 2010 City budget in order to accommodate the Local Homestead Tax Credit and the \$3.2 million in revenue lost due to the property tax caps enacted in 2008." The first reading of the resolution is scheduled to take place before the Finance Committee of the Evansville City Council on July 6th. On July 13th at 5:25 p.m., a public hearing will be held during the Council's regularly scheduled session in room 301 of the Civic Center. The Local Homestead Tax Credit must be passed by the Vanderburgh County Income Tax Council by August 1st.

A reminder that funds, which were available because the Local Homestead Tax Credit was not renewed for 2009, are being used for City operations. None of that money is being used for the arena project. Conversely, the revenue streams available for the arena project- downtown TIF, Food and Beverage Tax and gaming proceeds- can only used for capital projects like the arena as set forth in state and local law.

#### A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF EVANSVILLE APPROVING AN ORDINANCE OF THE VANDERBURGH COUNTY INCOME TAX COUNCIL ESTABLISHING THE PERCENTAGE CREDIT ALLOWED FOR HOMESTEADS FOR 2010 AND CASTING THE VOTES OF THE <u>COMMON COUNCIL OF THE CITY OF EVANSVILLE ON SAID ORDINANCE</u>

WHEREAS, I.C. 6-3.5-6-2 establishes a County Income Tax Council, provides that the membership consists of the fiscal body of the county and the fiscal body of each city or town that lies within the county, and authorizes the County Income Tax Council to establish the homestead credit in its county; and

WHEREAS, I.C. 6-3.5-6-4 provides that a member casts its votes by passing a resolution and transmitting the resolution to the Auditor of the County; and

WHEREAS, I.C. 6-3.5-6-7 provides that before a member may propose an ordinance or vote on a proposed ordinance, the member must hold a public hearing on the proposed ordinance and provide the public with notice of the time and place where the public hearing will be held; and

WHEREAS, I.C. 6-3.5-6-13 provides that an ordinance may be adopted after March 31 but before August 1 of a calendar year establishing the homestead credit for the following calendar year;

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Evansville, Indiana, as follows:

1. That the Common Council of the City of Evansville, Indiana hereby proposes an ordinance of the Vanderburgh County Income Tax Council amending the percentage credit allowed for homesteads at the maximum allowed by state law, not to exceed a net of 8%, to be funded out of local income taxes in 2010. A copy of said ordinance is attached hereto.

2. That the Common Council of the City of Evansville, Indiana casts its \_\_\_\_\_\_ votes for the proposed ordinance of the Vanderburgh County Income Tax Council, which ordinance reads as follows:

(Ordinance attached hereto is hereby incorporated herein.)

3. That the City Clerk of the City of Evansville is hereby directed to deliver an original executed copy of this Resolution and the proposed Ordinance of the Vanderburgh County Income Tax Council to the Auditor of Vanderburgh County forthwith.

4. The County Auditor is hereby requested to deliver an original executed copy of the Ordinance of the Vanderburgh County Income Tax Council, along with each local unit s resolution, to the appropriate State of Indiana agency so that the local homestead credit will become effective in 2010.

5. This Resolution shall be in full force and effect from and after its passage by the Common Council and signing by the Mayor.

## West Side Annexation Boundary to be Redrawn

(EVANSVILLE, IN)- Mayor Jonathan Weinzapfel and Councilman B.J. Watts yesterday announced changes to the boundary of the proposed West Side annexation area. It will now only include primarily commercial property along Pearl and Westin Drives.

"The public hearing on annexation gave the public an opportunity to respond to the proposal that was presented several months ago. We listened to concerns from folks on the West Side and made changes to our initial plan based upon their feedback," said Mayor Jonathan Weinzapfel.

The newly proposed area for annexation is bounded generally by Hogue Road to the north, Boehne Camp Road to the west and the commercial area south of the Lloyd Expressway. It measures about 326 acres and shares approximately 32.6% of its border with the City, which is greater than the one-eighth (12.5%) required by State Statute for annexation.

"Annexation is a logical next step in the growth of the City. By changing the proposed boundaries of the West Side annexation area, we have accommodated residents on the West Side while still adding to the City and increasing its tax base," said City Councilman, B.J. Watts.

The City will need to revise the legal description of the area to be annexed and amend the fiscal plan to incorporate these changes.

The assessed value of the area is \$137,058,500. Annexation will decrease the tax burden on Evansville residents because it will spread the City's property tax levy among more people and properties.

The Meaning of Neda

WASHINGTON -- Every revolution needs a unifying symbol, and members of Iran's opposition movement now have theirs.

That was one dumb sniper who took out the young woman millions now know as Neda. Or was he?

No one seems to know the identity of the rooftop shooter who pierced Neda's heart with a bullet Saturday. Was he a Basij sniper, as some witnesses have reported? Was it a mistake? Or did the shooter see an opportunity to create a necessary martyr?

The thought is inescapable that the beautiful Neda Agha Soltan might have been selected from the crowd not to scare away protesters, but to unite them.

It is not impossible to imagine that someone had a greater purpose in mind for the young philosophy student. If stories emerging from Iran are accurate, even Neda seemed to anticipate what might happen. When a friend begged her not to join the protesters, Neda said: "It's just one bullet and it's over."

Just one bullet was all it took. Neda reportedly died within two minutes, blood seeping from her nose and mouth as onlookers shouted "Do not be afraid." That phrase, a single word in Farsi, has become a chant among protesters.

In a matter of hours, a video of Ne-

da's death was circulated through You-Tube, Twitter and Facebook. No matter who pulled the trigger or why, Neda is now the undisputed symbol of reformminded Iranians' demand for freedom.

What follows next is by no means predictable, but history provides hints. Neda's anointment as a martyr could become crucial in the next month. Followers of the Shiite branch of Islam participate in cycles of mourning -- on the third, seventh and 40th days after death. These cycles served as rallying points during the 1979 revolution and conceivably could serve the same purpose now.

In the meantime, it is reasonable to ask why Neda so captured the imagination when many others have died since the June 12 election. On the same day that Neda died, at least 9 other protesters were killed.

At first, reports were that she was a teenager, just 16, walking with her father. Perhaps the world's initial reaction was tied to the belief that the government had slaughtered a child. Later, we learned that Neda was 26 and that the man with her was her music teacher. By then, the image of the young woman's dying face was firmly imprinted on the international psyche and the mythology of Neda had taken root.

What of all those others? Were they only men? Were they not as beautiful?

We are a video culture attracted to drama and beauty, an admission of which does not diminish the tragedy of Neda's death or the terrible loss for her family and friends. But as the days unfold, it will be interesting to watch how Neda, whose name means "The Voice" or "The Calling," is incorporated into the developing narrative of Iran and especially of Iranian women.

In fact, the protest movement's martyr needed to be a woman. And she needed to be a modern woman. It is noteworthy that Neda was wearing jeans and sneakers, uniform of the West, rather than the traditional garb of hijab or chador. Whatever's one attitude toward Muslim dress -- and many women don't feel the need to buck tradition -- it was clearly Neda's choice to ignore her government's preference that women hide their feminine features.

What better symbol for the repressive rule of old clerics than a liberated beauty brutally cut down in the prime of youth? Symbolically, Neda's death isn't about voting irregularities, but about the clash between superstitions that justify men's dominion over women and the universal yearning for freedom.

Women's rights were at the center of opposition candidate Mir Hossein Mousavi's reform agenda. His wife, Zahra Rahnavard -- in stark contrast to the nearly invisible wife of Mahmoud Ahmadinejad -- was front and center throughout the campaign urging a "religious democracy, which would allow young women of our time to thrive and flourish by providing them with security, freedom and employment."

That message may have been the sniper's target. With his bullet, he delivered another: Women either will behave and follow the rules, or they will die. Whatever the shooter's true aim, the body he left in the street has become immortal in the story of Iran.

Neda -- the voice of freedom -- can never be silenced now.

# A Young Woman's Letter to Congressman Ellsworth

Congressman Ellsworth:

I hope earnestly that this letter finds you and is not met by a go-between, glanced over, and trashed. My name is Stacey Kandel and I'm twenty-two. I live in Vanderburgh County, graduated from William Henry Harrison High School in 2005, went on to attend the University of Southern Indiana, and graduated with honors in December of 2008. I now work and live in that same community.

I share this with you because I want you to understand that we are "neighbors." Your wife is even my family's dental hygienist. Your family and my family drive on the same roads, go to the same parks, shop at the same stores, pay the same price for gas, have the same employment opportunities, and are watching the same businesses close their doors one after the other.

When I watch the news and C-SPAN, and see the amount of spending going on in Washington D.C. I am appalled, angered, and frightened. When I drive down Green River Road, I wonder what things will look like in the coming years. Will there be boards over all of the windows? Will there be cars on the road? Will Schnucks have a bread line? Will it have bread? Will the Presidential seal be on the doors of what were once privately owned businesses?

It is frightening to watch MY government, MY President appoint Czars to bypass YOU... the voice chosen for the people, by the people. It is infuriating to watch President Obama talk about his "respect" for the law, and his "reverence" for the U.S. Constitution, though his actions speak louder than his words. # **USI Teaching theatre approved in state budget**

A project long-awaited by the University of Southern Indiana was approved in the budget passed Tuesday by the Indiana General Assembly. The General Assembly authorized \$15 million in bonding authority for a teaching theatre to be located on campus.

The University's operating appropriation in 2009-2010 will be \$39,044,222, a decrease of approximately 3.3 percent from 2008-2009. In 2010-2011, the University's operating appropriation will increase by .3 percent to \$39,172,365.

The General Assembly also appropriated funds to restore operating support to the fiscal year 2009 level to institutions

of higher education through the American Recovery and Reinvestment Act of 2009. The University will receive approximately \$3 million over the biennium to be used for one-time expenditures and \$1.4 in 2009-2011 for repair and rehabilitation projects.

The teaching theatre, to replace the current offcampus facility and supporting buildings, was the University's number one capital priority for the 2009-2011 biennium. The proposed 350-seat theatre will replace the 50-year-old off-campus theatre located four miles from campus that is in the path of the future widening of Highway 62/the Lloyd Expressway.

Plans for construction of a performing arts facility have been part of the University's 10-year Capital Improvement Plan for almost 20 years, since 1991-1993. The proposed teaching theatre will be constructed adjacent to the expanded University Center. The initial authorization by the General Assembly allows the University to move forward on design of the project, which must then be reviewed by the Commission for Higher Education and the State Budget Agency before funds are released for construction.

Cynthia S. Brinker, vice president for Government and University Relations, said the University must carefully evaluate how to spend the federal stimulus money. "It's wonderful that we have these funds to fill in the gap, and it is going to bridge a difficult time, but we have to be mindful of the fact that the stimulus money is one-time funding and does not provide ongoing dollars. These funds will not carry into the 2011-2013 biennium."

Brinker acknowledged the hard work of local representatives during a tough special legislative session. "We are very appreciative of the work of our local legislative delegation and of the fiscal leaders in both the house and senate for their support of the University of Southern Indiana." she said.

# I Know What You Did Last Summer!

What will your teammates say about you when you report to practice this fall?

Most of you are familiar with the movie that had this title. The title referred to an event that the stars of the movie were trying to keep a secret. I would like to put this title in a more positive light. I want you to think about what your teammates are going to say about you when you show up to practice this fall. Are they going to be able to see a noticeable difference in the condition you are in? Will you be the one leading the sprints? Will you come to pre-season conditioning already in great shape?

I have had the opportunity to work with high school athletes and with Division I athletes at the University of Evansville and the University of Utah. Even at the college level it would always be obvious which of the athletes had put in a little extra effort over the summer. strength training program: pushups, pull-ups, squats, and lunges. These four movements will work every muscle in your body. As an athlete you are always moving and performing your skills on the go, so it is important to design your strength training programs around exercises that move your body through space rather than just machines. If you are strong enough to do these movements with extra resistance (especially the squats and lunges), that is even better.

The easiest way to improve your footwork is by jumping rope. Mix up how you jump (each foot, both feet together, running, etc.) and gradually try to increase the amount of time and the speed at which you jump. If you are familiar with dot drills and ladder drills those are great additions to your footwork and agility training.

My favorite method for training sprint speed is to sprint



There are four things that I would advise a junior high or high school athlete to focus on during the summer. These are:

1. Flexibility

2. Strength in Bodyweight Exercises

- 3. Footwork
- 4. Sprint Speed

Flexibility is probably the most forgotten component of most athletes' training programs. Stretching is boring, takes time to do right, and most people (especially guys) aren't very good at it, so it is often ignored. This is a huge mistake! Flexibility, particularly in the hips and hamstrings is a key component of sprint speed. If you can improve your flexibility and add an extra inch to your stride length it will make the difference of a step or more on your 40 yard dash and put you an extra step ahead of your competition.

As an athlete it is extremely important to be able to move and control your body through space. I strongly believe in four basic bodyweight movements as an essential component of an athlete's

# **Title IX Beat Goes On**

Two recent settlements involving Title IX claims have made news for their breath of application involving gender equity. One of the cases corrected the scheduling of girls' high school sports. The second case addressed the percentage of a university's participation in athletics by women athletes.

The Michigan High School Athletic Association (MHSAA) after 11 years in the judicial system agreed to pay \$6 million dollars in legal fees and to reschedule the girls' athletic schedule to be compatible with the boys'. The boys' athletic seasons mirrored the seasons utilized by colleges and universities. The Title IX lawsuit claimed that the MHSAA scheduling of girls' sports did not follow colleges and universities and was therefore detrimental to female athletes because it limited news coverage of their games and their ability to play for college recruiters that follow the university schedule. The United States District Court Judge agreed and ordered the MHSAA to reschedule the girls' athletic season.

The second case involved the University of California - Davis and three female athletes in club sports. In previous Title IX cases, the courts have held that a particular university or college is in compliance with Title IX if the proportion of athletes who are women is within 5 percent of the representation of women in the total enrollment. However in the settlement in the University of California - Davis case, the University is held to a stricter 1.5 percent standard or 3 times the previous accept-

uphill. This is a fantastic way to improve your sprint speed as well as strengthen your legs. Find a hill, (I use a few different driveways), sprint to the top and walk back down to the bottom. When you reach the bottom, sprint back up to the top. Start off with 3-5 repetitions and try to add one or two each week until you can do 20.

This summer, put forth a little bit of extra effort to improve these four areas: flexibility, strength in bodyweight exercises, footwork, and sprint speed, and next season when you show up for practice, your teammates will definitely be telling you, "I know what you did last summer!"

Davis has 10 years to bring female participation in varsity sports to within 1.5 percent of the proportion of the overall student population. The settlement provides for the addition of a women's field hockey team and the contribution by the University of \$110,000 to a fund that will help develop club sports. Additionally, Davis is permitted to trim the rosters of men's teams to comply.

At a time when the economy is negatively impacting athletic department budgets and women's enrollment is increasing universities will be challenged to minimize the impact upon women's sports and comply with Title IX's requirements.

# Near-record spring season for turkey in Indiana

The 2009 spring season harvest was Indiana's second highest since modern-day turkey seasons began 40 years ago, exceeding the 2008 harvest by 789 birds.

Of the approximately 59,000 hunters who pursued wild turkey in the state this spring, 12,993 were successful. Wild turkeys were killed in 88 of the 92 counties open to turkey hunting during the regular season, April 22 to May 10, and the youth season, April 18 and 19.

A total of 978 birds-7.5 percent of the statewide harvestwere taken during the youth season, which is held before the regular season.

"Adult gobblers made up 81 percent of the total harvest. Many hunters reported not seeing jakes (juvenile males) this spring. The below-average reproductive success of 2008, especially in those areas that experienced extensive flooding during the brood rearing period of early June, was a contributing factor," said Steve Backs, DNR wildlife biologist.

Backs said the reasons for the increased harvest number probably were a combination of general turkey population

growth around the state and the steady increase in turkey hunter numbers.

"Lower production was most evident in the western portions of the state, especially west-central Indiana, where the only regional decline occurred. . The south-central and southeast regions still account for more than 50 percent of the harvest. The harvest in the north region of the state continues to increase as those turkey populations grow, with several county harvests in the north taking over 200-plus birds," Backs said.

Switzerland County topped the hunter success list with 530 turkeys, followed by Harrison (511), and Jefferson (447).
