# **Board of Public Works Approves Health Care Clinic Contract**

(EVANSVILLE, IN) – The Board of Public Works this afternoon voted to approve a contract for Novia CareClinics to run a health clinic that will be free for non-represented City employees and their dependents.

This service is being offered to non-represented employees to help offset the 20% increase in health insurance premiums and other benefit changes. Funding for the clinic will come from insurance claims that would normally be filed with physicians.

"The City has had to make significant budget cuts to accommodate the property tax caps implemented by the State and lower tax revenues due to the downturn in the economy. In order to balance our budget, we have had to make changes to the benefits enjoyed by city employees," said Mayor Jonathan Weinzapfel. "I know that some of these changes will unfavorably impact our employees, but by opening this free clinic we are trying to mitigate the impact on household budgets and see additional budget savings over

time."

The clinic will provide all of the primary care services a patient would expect from a family physician or internist. Appointments will be made free of charge; and several dozen generic drugs will also be made available free of charge.

Once approved by the Board of Public Works, the City can move forward with plans to implement the clinic. It will be housed in the Civic Center in the office space on the third floor formerly occupied by the Purchasing Department. It is anticipated that the clinic will open by January 1, 2010.

Novia CareClinics are focused on providing employers with services for on-site medical care. Novia currently operates 21 clinics for 19 different employers including Vectren, Red Spot and the Town of Fishers. All medical personnel will be interviewed and selected by the City. Savings from the clinic will be realized in dispensing generic drugs, lower hourly rates and fewer hours of lost productivity.

# **Evansville Fire Department Wins 2 Statewide Awards**

(EVANSVILLE, IN) – This evening, the Evansville Fire Department received two prestigious awards at the 2009 Emergency Response Conference in Indianapolis: Basic Life Support Non-Transport Provider of the Year Award and Emergency Medical Technician of the Year. The conference is for all of Indiana's fire and EMS personnel and is sponsored by the Indiana Fire Chiefs Association.

"The Evansville Fire Department is comprised of great men and women who put their lives on the line every day for the citizens of this community. I commend them for the work they do to keep us safe and I applaud their efforts off the

> job as well," said Mayor Jonathan Weinzapfel. "I want to congratulate the entire department for earning these welldeserved honors."

> The Evansville Fire Department (EFD) was selected from a statewide pool of applicants as Basic Life Support Non-Transport Provider of the Year because of its commitment to its personnel and the community; and for raising the bar with regardtoprofessionalism and quality of patient throughout care industry.

> For instance, the EFD works with the local Community Emergency Response Team (CERT) to provide training and logistical support, and is on standby to deliver mutual aid to surrounding departments. The

department has four special teams: Rope/Confined Space Rescue Team, Hazardous Materials Team, Trench Rescue/Structural Collapse Rescue Team and Dive/Water Rescue Team. Firefighters are encouraged to further their training through education assistance.

Community involvement is a priority with the EFD. The public is encouraged to tour fire stations in order to learn more about the responsibilities of firefighters. The EFD also visits about 150 schools and functions each year.

The charitable contributions of the EFD are significant. The department raised \$30,000 for the Muscular Dystrophy Association in 2008 and \$18,000 for the St. Baldrick's Foundation for Child Cancer Research. A major fundraiser for the EFD is "Guns and Hoses," a charity boxing event in collaboration with the Evansville Police Department. Last year, the event raised \$45,000 which was divided among 15 charities and organizations.

As Emergency Medical Technician of the Year, Evansville Firefighter John Riggs is being honored for his proficiency in patient care, attitude of professionalism, and the respect which he receives from his co-workers and peers. Riggs is also being recognized for his contributions which go above and beyond the normal day-to-day experiences on the job.

A 15-year member of the Evansville Fire Department, John Riggs is active with the Hazardous Materials Team and the Rope/Confined Space Rescue Team. Away from the EFD, Riggs has co-chaired the construction of two Habitat for Humanity Homes utilizing only Evansville Firefighters and organized firefighters to help build the Kids Kingdom playground. Riggs volunteers each year at the A.C.T.S. (Answering the Call to Serve) Work Camp where youth from across Indiana repair homes and visit with some of the less fortunate residents of our community. Riggs still finds time to coach youth football, basketball, baseball, and soccer teams.

"The Evansville Fire Department is proud to have a group of such good hearted and dedicated men and women. They are very deserving of this honor and are to be commended for another job well done. We are glad that they have been chosen for recognition," said Chief Keith Jarboe, Evansville Fire Department.

# City Receives Favorable Sewage Bond Rating

(EVANSVILLE, IN) – The City of Evansville's Sewer Utility has positive news to report today. The Utility has received an Aa3 rating for its sewage bonds from Moody's credit rating agency, which is equivalent to the AA- rating the Utility received from Standard & Poor's in January 2009. Aa3 and AA- ratings mean the debtor (the Utility) has a very strong capacity to meet financial commitments. Moody's highest rating is Aaa; the highest Standard & Poor's rating is AAA.

"This is good news for Evansville because in this economic climate many communities have been downgraded because of negative bond rating results. While we attempt to use low-interest State Revolving Loan Fund dollars for large capital improvements to our sewer system, in instances where we have to go to the open market for bonds, this rating will enable us to receive lower interest rates and keep costs down," said Mayor Jonathan Weinzapfel.

Among the reasons cited for the Standard & Poor's January bond rating upgrade is the fact that the City is negotiating with the EPA to develop a long term control plan related to Combined Sewer Overflows (CSO's), and the net available revenue provides more than 3 times the coverage of the annual debt service.

Moody's Investors Service provides research data and analytic tools for assessing credit risk. Credit ratings and research help investors analyze the credit risks associated with fixed-income securities.

# Hitler in August

WASHINGTON -- Midway through the month's town hall meetings on health care, it seems the shark has jumped the shark -- and even Hitler must be sick of himself.

The terrible tyrant can't get a rest these days. For eight years, he was George W. Bush. Now he's Barack H. Obama. We just can't quit the monster with the fur lip.

His latest appearance is on a poster of Obama with the iconic mustache, which looks more like a missed crumb than a manly punctuation mark. The poster has become a favored accessory among some of America's squeakier wheels.

There is some debate about whether the Hitler resurrectionists are haters or faux haters -- i.e., Democratic Party plants aimed at making Republicans seem crazed.

Whatever the truth -- and Truth morphs by the moment -- it seems increasingly clear that the erstwhile shining city upon a hill has become 'Toon Town, a circus of media acrobats, political clowns and street-corner barkers.

Step right up and get your cotton candy, it's only a dollar and the show is free!

One recent sideshow, a town hall in Las Vegas available for viewing on YouTube, features an Israeli-American man railing to cameras when a woman nearby yells, "Heil Hitler." What?! The man turns to berate her: "You're telling me, 'Heil Hitler'? Shame of (sic) you!"

The camera rolls; the man continues shouting about the high cost of a recent hospital visit; the woman dabs her eyes to clear away fake crocodile tears. It's a wrap.

Next up, zoom to Dartmouth, Mass., where Rep. Barney Frank addresses a town hall at the Dartmouth Council on Aging. A woman holding an Obama-as-Hitler poster asks the congressman why he supports a Nazi policy.

To the apparent delight of many, Frank says he will revert to his ethnic heritage and respond to the question with a question:

"On what planet do you spend most of your time?"

Next he says that comparing the president's attempts to expand health care to Hitler is a tribute to the First Amendment and that trying to have a conversation with this woman would be like trying to argue with his dining room table. He chooses not to.

Hear, hear. Invocations of Hitler usually mean two things: one, a poverty of imagination, and two, a paucity of good arguments. It is nearly axiomatic that any protest against government action will feature Hitler in some form. Left and right are equally guilty.

Trivializing such evil is an insult to the memory of millions who suffered and died by his order, as well as to the intelligence of all sentient beings.

It may no longer be possible in this country to have a serious debate about anything. Inevitably, substance devolves into silliness. Even the most dignified of statesmen become caricatures when juxtaposed with the ridiculous.

While it's easy to blame "the media,"

there's no longer any single entity to indict. In a world where everyone has video -- and distribution is both free and easy -- every little thing is a "story." And so the exercised Israeli-American and his mocking nemesis become stars on the world stage. The Obama-Hitler woman may be only infamous, but she is a celebrity of sorts.

One may reasonably oppose Frank's and the Democrats' views on health care on the merits -- and plenty of informed people do. But when Frank is tossed into the ring with a Hitler-wielding instigator, he looks the sage from Vesuvius and his opponents escapees from the asylum.

Given the choice of company, which would you prefer?

Never mind whether any of the rabble-rousers would be known were it not for the ever-present cameras and microphones. Would they have performed as they did -- yelling and aping -- had there been no one on hand to record their antics?

Alas, we can't even critique the phenomenon known as Heisenberg's Principle of Observation without circling back to Herr Hitler. Physicist Werner Heisenberg, leader of Hitler's atomic bomb project, came up with an "uncertainty principle" that has been used -- some say misused -- to suggest that things observed are altered by the fact of observation.

Translation: When you turn on the camera, the presence of the camera alters whatever transpires.

There isn't much we can do about the convergence of technology and the persistent plague of narcissism, but there is something we can do about Hitler. The moment he shows up in any form, turn off the cameras. Consider it an act of nonviolent protest -- and self-respect.

## WHAT IF I WOULD'VE TOLD YOU...

#### MOST OF ALL OF THIS HAS ALREADY HAPPENED

Publisher's Note: Although it is not customary for us to put items such as the one on this page in the newspaper, we felt the message below was worthy of print because it is factual in nature and proves the point behind local groups working hard to maintain their civil liberties as American citizens. The message below was forwarded to the City-County Observer last week. We encourage your comments.

What would you say if I gave you 11 reasons why the elections in 2010 will be the most important in the history of the United States?

1. What if I had told you in October 2008, before the last presidential election, that before Barack Obama's first 100 days in office, the federal government would be in control of both the mortgage and the banking industries? # **HISTORY TEACHERS**

Jerry and Marsha King of Mt. Vernon, Indiana are teachers. They may have matriculated from the organized school system, but they continue to give generously of their knowledge. Although I have known Jerry and Marsha for over a quarter of a century, our friendship began in earnest when their son, John, and our son, Jim, along with several other Posey County young people were called to serve in the Gulf War (1990-1991).

War has a way of concentrating a parent's thoughts and bringing parents together. Since the Gulf War, it has been my pleasure to learn first hand about Jerry and Marsha's extensive knowledge of Posey County history. Jerry, as Major-General Alvin P. Hovey, and Marsha, as Mrs. Hovey, often portray our most famous citizen and his wife.

Jerry has numerous Civil War Era artifacts, a full uniform and a wealth of knowledge about Hovey and Posey County during the Civil War. He and Marsha, also, have created a living laboratory of learning concerning the 1830's through the 1880's known as the Old Solitude Pioneer Village. It sits on part of the Kings' property right on Big Creek and right where the tracks of the railroad used to run.

Marsha gave me their Mission Statement:

"What we are attempting to do on about an acre of our small farm at Solitude is to recreate an early pioneer village landscape of around 1830.

In America today there is the mentality of, 'throw away the old and make way for the new.' We want to save examples of our heritage.

Our primary mission is to acquire, restore, preserve and exhibit pioneer items for the purpose of educating the youth and adults of today."

Seldom has a couple accomplished their objectives so well. When I walked through the hand-hewn log structures made with notched dove-tailed and half-notched corners complete with hand chinking and rock, mud and stick chimneys, I left the worries of crashing stock markets and entered Abraham Lincoln's and Alvin Hovey's 19th Century Posey County.



Jerry and Marsha started their restoration project in 1973 and have worked hard on it ever since. They have created an amazingly impressive 1830's pioneer village complete with a church, a store, a school, a smokehouse, two cabins, a well, several stock pens and sheds and the old railway weigh station.

The fine efforts of Mr. and Mrs. King to help scout troops, school children, civic clubs and the general public to appreciate the hardy men and women who built our county and our country have been recognized by the National Society of the Daughters of the American Revolution Conservation Committee, which in 2005 awarded the Solitude Village first place in the East Central Division, and which in 2005-2006 praised Jerry and Marsha for their "Outstanding Achievement for Environmental Awareness."

Jerry and Marsha will, once again, be helping to educate all of us at the Mt. Vernon River Days on September 11th and 12th.

Next week I plan to take those of you who want to see how old Abraham and Alvin lived and practiced law inside the King's representation of Lincoln's old Illinois law office. Come rejoin the tour of Jerry and Marsha's fabulous teaching endeavor.


the schools, energy production, the environment, health care, and the wealth of every US citizen.

reputation, and reasonable cost of attendance.

# McNamara to receive Lawrence Senesh Award for School Administrators

Wendy McNamara, Director of Early College High School in Evansville, Ind. has been selected to receive the prestigious Lawrence Senesh Award for School Administrators from the Indiana Council for Economic Education (ICEE). # **UE Announces Berger Award Winners**

he University of Evansville is pleased to announce W. Bryan Lynch and David E. Mitchell as the winners of the 2009 Sadelle and Sydney Berger Awards, given annually to members of the UE faculty for both scholarship and service.

Lynch, an associate professor of chemistry and chair of UE's chemistry department, received the award for scholarship, while Mitchell, an associate professor of electrical engineering, earned the award for service. Both awards were given at the University's annual Fall Faculty & Administrator Conference by UE Senior Vice President for Academic Affairs Susan Kupisch, who presented the awards on behalf of the Berger family.

"Every year, it is our distinct pleasure to honor two members of our faculty with the Berger Award," said UE President Stephen Jennings. "This is one of the most prestigious awards our University can bestow upon its faculty; through their exceptional research and service to UE, Bryan Lynch and David Mitchell have more than earned the recognition they receive today."

Mitchell, who came to UE after a stint as the chief systems engineer for Sensitrol, Inc., in Albion, Illinois, earned the Berger Award for service through his tireless "off-the-clock" work for

the University's College of Engineering & Computer Science. As a member of that department's faculty, Mitchell is an annual volunteer instructor at the college's OPTIONS programs, as well as a frequent presenter of lectures and demonstrations for prospective students at UE Open House weekends. He has been faculty advisor for innumerable electrical and computer engineering student projects, a technical advisor for nearly every student project in his department, and a guide for students as they prepare for regional, national, and international engineering competitions each year. He also acts as a frequent consultant to the University community and its professional alumni in areas of electronic circuit and microprocessor applications.


An alum of the University of Evansville, Mitchell received a B.S. in electrical engineering from UE, before going on to earn an M.S. in physics and astronomy from the University of Toledo. He has been employed at the University of Evansville since 1976.

Lynch, who earned the Berger Award for scholarship, was rewarded for his research into the study of small molecules. Using a nitrogen-pumped dye laser, Lynch has studied the structure of

electronic excited states of small molecules in the gas phase – including a two-semester period in 2007 when he took a sabbatical in Massachusetts to study in the research labs at MIT. His project, supported by the Lilly Endowment, Inc., the Petroleum Research Fund, and the American Chemical Society, led him to work with isocyanogen, CNCN, to observe and determine the structure of its first electronically excited state – something that had never been done before.

Lynch earned a B.S. in chemistry from the University of Pittsburgh, and earned his Ph.D. in physical chemistry from the same institution. Before coming to UE in 1994, he worked as a research scientist at several companies in Pennsylvania, including Advance Materials Corporation and Gulf Research and Development Co., where he was a project leader.

The Berger Awards are presented annually in memory of Sadelle and Sydney Berger. Sadelle was a UE graduate and life-long member of the Academy of Arts and Sciences at UE. Sydney was a well-known local attorney. Both dedicated their lives to public service. The Berger family established the endowment to give recognition to faculty at the University of Evansville.

# Eagles Women's hoops announce 2009-10 schedule

EVANSVILLE, Ind.—The University of Southern Indiana women's basketball team announced that it will open its 2009-10 schedule at the Disney Division II West Coast Tip-Off Classic in Anaheim, California, October 30-November 1.

USI plays three of its 29 regular-season games at the Disney Division II Tip-Off Classic, including a match-up with nationally ranked Fort Lewis College (Durango, Colorado).

Following their trip to California, the Screaming Eagles visit Indiana State University November 8 for an exhibition game before visiting Midwest Region foe Wayne State University November 15

Including Wayne State, the Eagles play 11 games against nonconference competition and three games against teams from the Great Lakes Intercollegiate Conference.

The Eagles' home schedule, which opens with a three-game stretch November 18 against NCAA II newcomer Urbana University, features 14 games. In addition to Urbana, the Eagles host Marygrove (November 22) and Lincoln Memorial University (November 24).

USI participates in the Bellarmine Thanksgiving Classic in Louisville, Kentucky, November 28-29. USI will square off against the University of Saint Francis (Indiana) to begin the two-game stretch before ending the swing with a bout with GLIAC foe Hillsdale College.

The Eagles return home December 3 to open Great Lakes Valley Conference play against Bellarmine University before hosting

defending GLVC champion Northern Kentucky University December 5.

With the addition of the University of Illinois-Springfield and Maryville University, the GLVC has moved to three five-team divisions (East, North, West). The Eagles will compete in the East Division against their more natural rivals, Bellarmine, Northern Kentucky, Kentucky Wesleyan College, and the University of Indianapolis.

USI plays each team from the East Division twice in 2009-10, while it plays teams from the North and West Divisions once.

The Eagles games against Bellarmine and Northern Kentucky in early December start a six-game homestand, the Eagles' longest home stretch of the season. USI also hosts the University of North Alabama (December 9), Ferris State University (December 30),

Illinois-Springfield (January 2), and Saint Joseph's College (January 4) during the six-game stand.

USI makes its first GLVC road trip of the season January 7 when it visits Missouri University of Science and Technology. USI also visits Maryville University January 9 before traveling to Owensboro, Kentucky, to take on Kentucky Wesleyan January 14.

The Eagles' only home game during an eight-game stretch comes against defending GLVC regular-season champion Quincy University January 16. Following its game with the Hawks, the Eagles get on the bus for Springfield, Missouri, and Drury University for a four-game road trip that includes stops at Indianapolis (January 21), the University of Wisconsin-Parkside (January 28), and Lewis University (January 30).

USI wraps up its home schedule with a four-game homestand beginning February 4 when the Eagles host the University of Missouri-St. Louis. USI also hosts Rockhurst University (February 6), Indianapolis (February 13), and Kentucky Wesleyan (February 15).

The Eagles conclude the regular season with trips to Northern Kentucky (February 18) and Bellarmine (February 20).

This year's GLVC Tournament will have a different format, as it will be played in a two-week span, with the first and second rounds being hosted on campus sites February 27-28. The semifinals and championship will be hosted in Springfield, Illinois, March 6-7.

The NCAA II Midwest Regional is March 12-15 on campus sites, while the NCAA II Elite Eight is March 23-26 in St. Joseph, Missouri.





# Endeavor Awards offer more funding to students and faculty

Students and faculty who want to complete a research project, produce a literary work, artistic project, multimedia presentation, or technical programming, or present research at a conference can receive additional funding through the Endeavor Awards being offered at the University of Southern Indiana.

The Endeavor Awards for Research and Creativity are replacing the Research, Innovation, Scholarship, Creativity (RISC) program.

"The Endeavor Awards for Research and Creativity is a funding program across all disciplines with more muscle than its predecessor," said Dr. Jim Durbin, associate professor of geology, who directs the program with the assistance of Dr. Brian Posler, assistant provost for Undergraduate Studies.

"The funding available to support individual work has increased for all projects. The new program also has removed several restrictions on how funding may be spent, including an option that allows student to be paid to work on the project. A new option has been added to allow for faculty to more easily incorporate students into their academic research areas by allowing faculty to be the primary author on the proposal, provided students are brought into the project."

#### Two funding options plus travel grants

The program offers two categories of research and creative work grants.

- With awards up to \$1,500, students can be principal researchers, authors, artists, playwrights, or creative directors under the guidance of a faculty member.
- Grants up to \$3,500 are available for faculty as primary researchers who receive meaningful involvement from students. Students have to make substantial contributions to the research by presenting at a conference or being listed as co-author on publications.

Endeavor's Presentation Award offers travel grants of up to \$1,000 to help defray the transportation and hotel costs students can incur when they are presenting their research or creative projects at professional and academic meetings.

#### First Friday deadlines

Applications for the funding research proposals will be accepted throughout the year. Submissions will be due at 4:30 p.m. on the first Friday of September, October, November, December, February, March, and April. Applications forms are available online at www. usi edu/endeavor

#### Hatch a New Idea promotion

"A marketing effort is underway across campus to generate interest in the program," said Durbin. "You'll see the 'Hatch a new idea' marketing message and the new Endeavor Awards logo on posters, the USI web site, and in advertising across campus.

"As the promotion suggests, 'Hatching poultry from an egg is

routine, but hatching a robotic chicken from a golden egg is worth exploring.' We want students and faculty to participate and enter their new ideas for the Endeavor Awards."

Endeavor Awards will sponsor an undergraduate research symposium in April of each year. Student researchers, faculty sponsors, faculty researchers, and students contributing to faculty research have the opportunity to present their completed work at the event

Durbin said, "Anyone who has done research or creative works of any kind, regardless of whether or not they have received monetary support from the Endeavor Awards is encouraged to present their effort at the Endeavor Undergraduate Research Symposium," said Durbin. "Of course those who do receive funds are required to present their work," he added.

The web site at www.usi.edu/endeavor offers more information about the qualifications for grant proposals and presentation awards.

The first application deadline for Endeavor Awards is September 4, 2009.

## **End-of-Life Care Guide for Veterans**

The Health Care Debate in Washington and across our Country is heating up. We are bombarded from the Left and the Right about what is good for us. We have all heard about the results of Socialized Medicine in England and Canada. This should be fair warning. I am a Marine, retired after 24 years service. I received a disturbing email about End of Life Care for Veterans. I decided it is time to research this question. The last reference is for the manual (Your Life, Your Choices) from the Veterans Administration, the preceding links reference.

Sen. Arlen Specter has called for hearings to scrutinize a guide for veterans' end-of-life care which one former Bush official says sends a "hurry-up-and-die" message to injured troops. The guide, called "Your Life, Your Choices," was suspended under the Bush administration but has been revived under the current Department of Veterans Affairs.

Jim Towey, former director of the White House Office of Faith-Based Initiatives, told "FOX News Sunday" that the document makes injured veterans feel like a burden, encourages the severely injured to die and should be tossed out.

Specter, a member of the Veterans' Affairs Committee, said it raises "a lot of questions" and that he would call for hearings immediately. "I think consideration ought to be given right now to suspending it pending hearings," Specter, D-Pa., told "FOX News Sunday."

Towey first wrote about the revival of the manual last week in The Wall Street Journal.

"This is a slippery slope," he said Sunday. "When you look at the book it makes people feel like they're a burden and they should do the decent thing and die. ... When a veteran comes back from Iraq, they shouldn't be given a book like this."

Towey called the guide "fundamentally flawed" and said it should be pulled from the Web site.

But Tammy Duckworth, an injured

veteran who is the assistant secretary for the Department of Veterans Affairs, said the manual is still under revision -- as stated in a disclaimer on the official Web site -- and has not officially been "reinstated."

She said it was one of many options for injured veterans, calling it "simply a tool."

"This ultimately is about the ... health care for veterans," Duckworth said.

Though Duckworth said the document has not been fully vetted, an official directive from July tells VA health practitioners to refer veterans to the document. Duckworth questioned whether that directive had been authorized at the highest levels.

Towey said the questions posed by the guide embed the suggestion that veterans who are suffering may want to choose death.

One section titled, "What Makes Your Life Worth Living?" offers a checklist of scenarios -- the person filling out the form is asked to rate whether life would be worth living under each of them.

"I am a severe financial burden on my family," says one of them. "My situation causes severe emotional burden for my family," says another.

If President Obama wants to better understand why America's discomfort with end-of-life discussions threatens to derail his health-care reform, he might begin with his own Department of Veterans Affairs (VA). He will quickly discover how government bureaucrats are greasing the slippery slope that can start with cost containment but quickly become a systematic denial of care.

Last year, bureaucrats at the VA's National Center for Ethics in Health Care advocated a 52-page end-of-life planning document, "Your Life, Your Choices." It was first published in 1997 and later promoted as the VA's preferred living will throughout its vast network of hospitals and nursing homes. After the Bush White House took a look at how this document was treating complex health and moral issues,

the VA suspended its use. Unfortunately, under President Obama, the VA has now resuscitated "Your Life, Your Choices."

Who is the primary author of this workbook? Dr. Robert Pearlman, chief of ethics evaluation for the center, a man who in 1996 advocated for physician-assisted suicide in Vacco v. Quill before the U.S. Supreme Court and is known for his support of health-care rationing.

"Your Life, Your Choices" presents end-oflife choices in a way aimed at steering users toward predetermined conclusions, much like a political "push poll." For example, a worksheet on page 21 lists various scenarios and asks users to then decide whether their own life would be "not worth living."

The circumstances listed include ones common among the elderly and disabled: living in a nursing home, being in a wheelchair and not being able to "shake the blues." There is a section which provocatively asks, "Have you ever heard anyone say, 'If I'm a vegetable, pull the plug'?" There also are guilt-inducing scenarios such as "I can no longer contribute to my family's well being," "I am a severe financial burden on my family" and that the vet's situation "causes severe emotional burden for my family."

When the government can steer vulnerable individuals to conclude for themselves that life is not worth living, who needs a death panel?

One can only imagine a soldier surviving the war in Iraq and returning without all of his limbs only to encounter a veteran's health-care system that seems intent on his surrender.

I was not surprised to learn that the VA panel of experts that sought to update "Your Life, Your Choices" between 2007-2008 did not include any representatives of faith groups or disability rights advocates. And as you might guess, only one organization was listed in the new version as a resource on advance directives: the Hemlock Society (now euphemistically known as "Compassion and Choices").

This hurry-up-and-die message is clear and unconscionable. Worse, a July 2009 VA directive instructs its primary care physicians to raise advance care planning with all VA

patients and to refer them to "Your Life, Your Choices." Not just those of advanced age and debilitated condition—all patients. America's 24 million veterans deserve better.

Many years ago I created an advance care planning document called "Five Wishes" that is today the most widely used living will in America, with 13 million copies in national circulation. Unlike the VA's document, this one does not contain the standard bias to withdraw or withhold medical care. It meets the legal requirements of at least 43 states, and it runs exactly 12 pages.

After a decade of observing end-of-life discussions, I can attest to the great fear that many patients have, particularly those with few family members and financial resources. I lived and worked in an AIDS home in the mid-1980s and saw first-hand how the dying wanted more than health care—they wanted someone to care.

If President Obama is sincere in stating that he is not trying to cut costs by pressuring the disabled to forgo critical care, one good way to show that commitment is to walk two blocks from the Oval Office and pull the plug on "Your Life, Your Choices." He should make sure in the future that VA decisions are guided by values that treat the lives of our veterans as gifts, not burdens.

## Deig appointed to study committee on gaming

Interim legislative study to review numerous proposals on the state's regulation of gaming

INDIANAPOLIS – Indiana Senate President Pro Tem David Long (R-Fort Wayne), upon recommendation by Senate Democrat Leader Vi Simpson (D-Ellettsville), has appointed State Senator Bob Deig (D-Mount Vernon) to serve on the Interim Study Committee on Gaming. The committee will review a number of gaming issues including land-based gaming, non-smoking accommodations in riverboat casinos and racinos, and gaming license fees. Deig has also been assigned to the Interim Study Committee on Alcoholic Beverage Issues which will review the sale and distribution process of alcohol in Indiana, presumably including Sunday sales.

Additionally, Deig serves on the Workforce Innovation Council, Water Resources Study Committee, Regulatory Flexibility Committee, New Harmony Commission, Pension Management Oversight Commission, and Advisory Commission on Intergovernmental Relations.

Other topics assigned for review this year by the General Assembly include the following:

Education: The Interim Study Committee on Education will address issues including early school start dates, the

need for after-school programming, and the funding and availability of statesponsored, locally administered adult education programs.


School funding: A separate Interim Study Committee the School on Funding Formula has been formed to review the existing formula and make determinations on how the formula could be adapted to better accommodate the needs Indiana's schools.

Unemployment fund oversight: The Unemployment Insurance Oversight Committee was established this year to provide legislative review and recommendations to improve the solvency of the trust fund for the state's unemployment benefits.

Victim's compensation: The Sentencing Policy Study Committee has been assigned, among other topics, with the review of the delayed payment of claims from the Victim Compensation Fund administered by the Indiana Criminal Justice Institute.

The General Assembly annually convenes interim study committees and permanent commissions to conduct indepth research and analysis of issues affecting the state. Recommendations from these committees are often the basis for future legislation.
