Exhausted, I put my pen down and began to close my notebook when Libby told me she had another surprise for me. I looked at her with anxious anticipation, sweat pouring from my temples. It was then Libby told me about the coffee shop on St. Joe. Obviously, something important had just happened there. It's nothing fancy, just an old German place with a good cup of java. Libby came in on a rainy morning dripping cold water from head to toe. The only seat left was at an obscure table in the back. Her usual waitress brought over a steaming cup of caffeine. Libby held in her hands warming her fingers. A man, sitting to next her, in a dark coat with the hood pulled tight over head murmured, his voice sounding like gravel under a tractor, "It that you green eyes?" Libby knew that voice instantly and couldn't believe her eyes. It was Maurice, aka the Mole. His face was scared from years of covert activity. ### TAA Assistance Approved for Whirlpool Workers

(EVANSVILLE, IN)- Mayor Jonathan Weinzapfel has just been informed that the U.S. Department of Labor has certified Whirlpool workers for Trade Adjustment Assistance (TAA).

Whirlpool workers who were terminated on or after December 6, 2008, or have been threatened with termination through January 19, 2012 are eligible to apply.

"This is a difficult time for Whirlpool workers and their families who are faced with an uncertain future when the Evansville plant begins closing in the spring. The fact that they are eligible for TAA will certainly help them as they make this transition," said Mayor Jonathan Weinzapfel. "We are grateful to Senators Bayh and Lugar, and Congressman Ellsworth, for their support in getting this certification for Whirlpool workers."

The Department of Labor's investigation found that Whirlpool workers satisfied the criteria for receiving TAA. Those criteria include:

1. A significant number of workers have become totally or partially separated from employment.

2. The production of goods by the workers' firm has been shifted from the U.S. to a foreign country.


TAA was created to provide benefits and support workers who become unemployed due to the impact of international trade. Workers can now apply for benefits and services such as: 156 weeks of full- or part-time training, a tax credit covering 80% of the worker's monthly premium for qualified health insurance, and monies to fund a job search.

# ASK THE TAX MASTER TIP INCOME

I had a young lady at my desk that is a waitress at a restaurant in a large hotel on Hwy 41 North last night. She mentioned that the management of that restaurant, had told her that it was required she report 15% of the sale as tip income and nothing more.

Similar to last week, when I complained that attorneysat-law should keep their advice to law and not taxes, so should managers of restaurants not try and give advice to the waiters/waitresses concerning what should be reported as tip income on a tax return.

This particular waitress had earned \$3,990 in wages by the restaurant. The W2 showed tip income of \$291 only.

Since this is the lady's only income, and she has one child reporting on a tax return, this income will generate an earned income credit of \$1,352. She would receive a refundable child tax credit of \$148. If she actually received and reported \$2,000 in tips, that she thinks she

is better off not reporting, she would receive an earned income credit of \$2,092 and a refundable child tax credit of \$448. Out of the credits there would be a payment of \$150 to self-employment tax. The additional payments into the social security account allows a larger amount to be drawn on when she is old enough to receive the benefits.

This does not mean I support the notion of inflating income solely to get larger refunds. It does mean I do not support restaurant management encouraging employees to lie and minimize their income, especially when oftentimes it costs the person that qualifies as being poor monies to which they are entitled, but have no idea they are in fact entitled to the benefits!




