## Klenck Company promotes 'green' initiative through demolition of Executive Inn

The City-County Observer has received a number of phone calls about a pile of rubble on First Avenue near the old Igelhart Mill. The pile was the remnants of the Evansville Executive Inn demolition. That same mound of debris is now being ground and separated into materials that can be recycled versus the traditional practice of dumping the entire building in the landfill.

Evansville-based Klenck Company is a leading the way locally for green, environmentally-friendly demolition and building efforts. From the street, it looks as though a company just dumped a mangled pile of concrete and steel in the middle of the city, but take a spin into the nearby parking lot, and it's evident much more is going on than meets the eye.

When staff members first began checking on this mound of concrete, steel and other materials, it was a mere growing mound. Questions arose regarding the health and safety concerns for residents around the dump site.

Phone calls were made to the Keep Evansville Beautiful, the Vanderburgh County Health Dept., and the Indiana Dept. of Environmental Management to see if they knew about the pile. IDEM informed the City-County Observer that a permit had been issued to Fligeltaub. Their permit allows them to temporarily use the First Avenue site.

According to the Klenck Company website, Fligeltaub



Recycling Inc. is the parent company. According to the Indiana Secretary of State's Office, the legal entity name is Tim Klenck Demolition LLC. Alan N. Shovers is listed as the Registered Agent, and the entity creation date was October 17, 2008.

A visit to the dump site, revealed that Klenck was in fact handling the demolition and recycling efforts. In a conversation about the project with Director of Marketing and Business Development Nicholas Funke, Klenck is dedicated to its green initiative and acting in a fiscally responsible manner.

Funke explained how the grinder works as workers used heavy equipment to move materials to their proper locations. A backhoe dumps a bucket of rubble into the grinder. Workers watch as materials are dumped to en-

sure that they arrive in the proper piles of recycled concrete, metal and landfill items. A small pile to the west is filled with items for the landfill, while a giant magnet attached to a piece of heavy equipment moves scrap metal to a dumpster to be hauled off. A rapidly growing mound of concrete and rock is hauled near the road. Water is used to keep the dust to a minimum so the local residents will not have to deal with dust in the air.

Funke then stated that Klenck plans to sell the recycled concrete as fill. They hope to sell the large volume of material to a company directly from its current location.

When asked how this aspect fit into the bid portion of the project, he was armed with an answer that when checked, proved to be precisely how they do business. "We have been doing this for a long time. We have a great deal of experience. Before we bid on a project, we get all the information. We walk through the building. We look at the building plans. We know what is in the building, so we know how to bid the job," said Klenck.

As the discussion continued, Funke excitedly explained

how much the company focuses on being good environmental stewards. "We try to send as little as possible to the landfill."

In fact, Klenck is a member of the U.S. Green Building Council and the National Demolition Association.

According to the Klenck website and officials with the arena project, all schedules were met, and 81 percent of the Executive Inn's building weight has been recycled.

Klenck has been awarded the demolition contracts for three facets of the arena project and new hotel. They performed the removal of structures on Main Street, arena recycle hauling and the Executive Inn. They also handled the demolition and hauling tasks for Cedar Hall School, Berry Plastics and the Vanderburgh County Jail.

In checking campaign finance reports, no direct donations were noted by Klenck Company.

Note: This company should be commended for its work a good corporate citizen, as should the Evansville Redevelopment Commission for awarding contracts to a quality local company.

## New Homes, New Construction and Demolition Front Door Pride in Action

Mayor Jonathan Weinzapfel has announced not only the completion of eight new Front Door Pride homes, but also the start of the construction of seven more.

The new homes are located at 1201, 1217, 1221, and 1228 Culver, 105 Madison, 301 Jefferson, 28 Washington, and 401 SE 3rd Street. In addition, construction will soon begin on Front Door Pride homes at 38 Washington, three in the 100 block of Adams, and three others on lots to be determined which will bring the total number of new homes to 21.

"A transformation of this neighborhood is well underway. People who haven't been to this area in awhile will be able to see a noticeable change in its appearance," said Mayor Jonathan Weinzapfel. "Front Door Pride will press ahead with its mission to get rid of eyesores and construct new homes in order to reverse decades of neglect in some of Evansville's oldest neighborhoods."

There are properties in the Front Door Area which simply cannot be saved. Either their condition has deteriorated to the point where they are no longer structurally sound, or the cost to bring them up to code is many times more than the building is actually worth. Since the beginning of 2010, there have been 22 buildings razed in the Front Door Pride area. Last year, 61 buildings were demolished. Compare that to 2006-2008, when only 29 structures were razed in 3 years.

Construction began on the eight newly-completed Front Door Pride homes in October 2009. Each has sustainable features including high-efficiency heat pumps, low-flow shower heads and toilets, tankless water heaters, Energy Star lighting fixtures, all foam or blow-in insulation, and a thermal radiant barrier in all side walls.

Buyers of any income level will be considered for purchase of Front Door Pride homes; however, grant incentives are tied to households with incomes below 125% area median income (AMI). More incentives are available to households with incomes below 80% AMI.

Buyers must have enough income and acceptable credit to secure a mortgage with a local lender and make a minimum down payment of \$500. HOPE of Evansville will prepare and assist potential buyers, who must also complete a pre-purchase class. ## New Director of Evansville EPA Named

(EVANSVILLE, IN)- Mayor Jonathan Weinzapfel has appointed Derrick J. Ohning to serve as the Director of the Evansville Environmental Protection Agency (EEPA), which is now part of the City's Department of Sustainability, Energy & Environmental Quality (SEEQ). He will report to SEEQ Executive Director Dona Bergman.

Ohning most recently served as Compliance and Enforcement Manager for the Indiana Department of Environmental Management (IDEM), Office of Air Quality, Southwest Regional Office. He holds several certifications from the U.S. EPA, the California Air Resources Board, IDEM, and other organizations in thermography, wastewater treatment, surface coating operations, opacity reading, continuous emissions monitoring, asbestos handling, inspection and enforcement, hazardous materials, and safety. Ohning also identified and documented justification for revisions to federal rules and received special recognition from IDEM for his work involving a methamphetamine bust in Posey County.

Prior to Ohning's regulatory oversight work, he gained extensive industrial experience while employed at Robur Corporation in Evansville as Environmental and Facilities Manager, ISO 9000 Management Representative, Maintenance Supervisor, Staff Chemist, and conducting research under a grant from the U.S. Department of Energy.

A native of Southern Indiana, Ohning attended the University of Southern Indiana where he earned a B.S. in Chemistry, worked as a laboratory assistant, and served as President of the American Chemical Society student affiliate chapter. He also has participated in the Ohio River Sweep and served as judge in the regional science fair.

# LETTER TO THE EDITOR

## A citizen's explanation of politics

The user is adamant, and expresses no regrets. He insinuates that anyone who would find fault with his actions, given the "circumstances" is an "enemy of democracy," or "enemy of the people," or an "enemy of progress."

3. ADMISSION, APOLOGY AND WITHDRAWAL ("AAW") - This is the strategy where the

user admits to the accusations, apologies to his family in a press conference, and withdraws from public service because he either a) does not want any scandal to interfere with the higher directives of his former office, sport, team, etc., or because b) he does not want his family to be tormented and harrassed by news reporters, investigators and other persons who would seek to capitalize (i.e., to earn a living or win a conviction) on his misdeeds. It's always good to do things for the protection of one's beloved family.

*Exemplary Users: Too many to mention ... but keep watching the news about politicians who have either fibbed or misled others about their heroic military service... or those who have had a tryst or two with an intern or subordinate...*

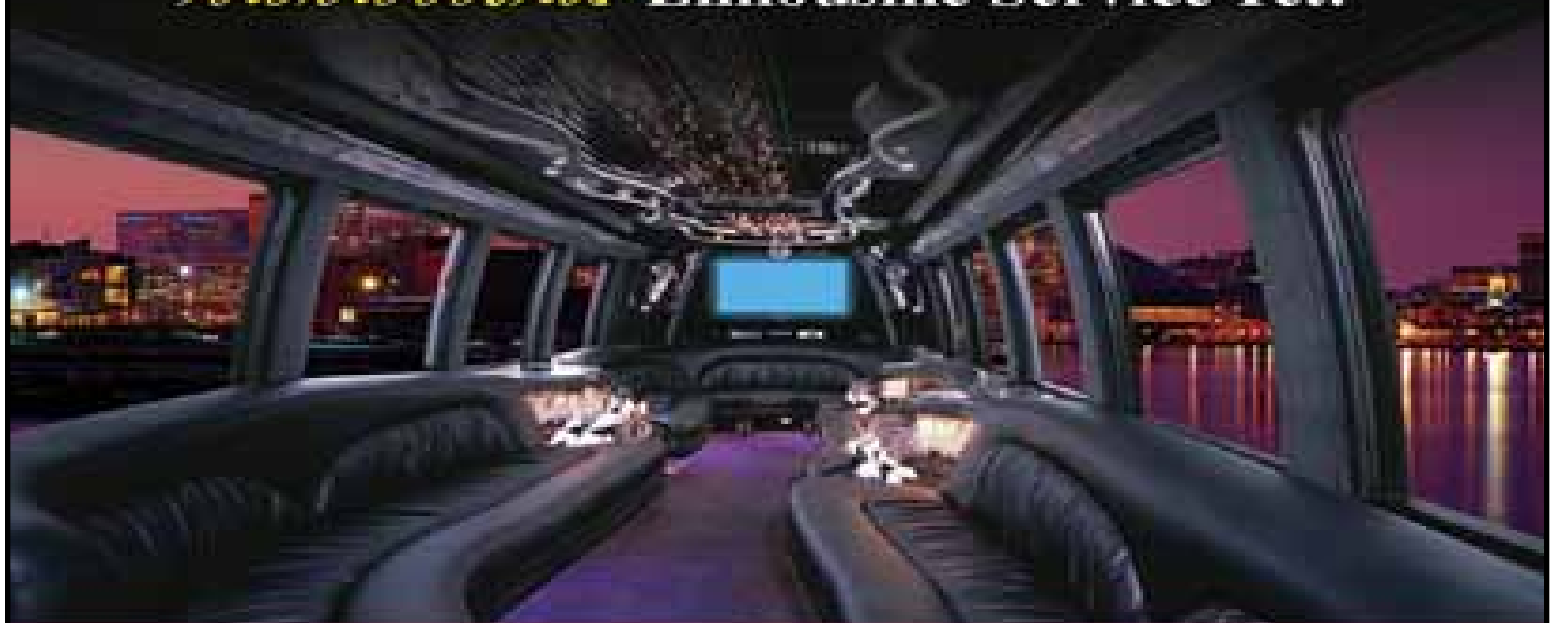

## UE Announces Successful Conclusion of Largest Campaign

The University of Evansville is proud today to announce the successful conclusion of its largest-ever capital campaign, U•Envision 2010.

The campaign, which was publicly launched in September 2007 with a goal of raising \$80 million, is ending six months ahead of schedule, after exceeding its goal by more than \$2.6 million. To celebrate – and as a “Thank You” to many of the University’s most generous supporters – University administration held an event this evening at Mesker Park Zoo & Botanic Gardens for members of the UE President’s Club. It was during that event that the official campaign total was first announced.

The official total raised during the U•Envision 2010 campaign is \$82.68 million.

“As chair of the campaign committee, it was my goal to be able to successfully conclude the U•Envision 2010 capital campaign before the announced retirement of President Stephen Jennings,” said UE Trustee Alan Braun, chair of the U•Envision 2010 Campaign Committee. “This evening, I am extremely proud to say that we have not only met that goal, but thank to the dedicated efforts of this committee, our alumni campaign committees in several cities across the country, and of course the tireless work of the UE Development team, we have exceeded that goal by more than \$2 million.

“I want to thank everyone who was involved in making the U•Envision 2010 campaign a tremendous success.”

U•Envision’s launch came with three stated goals: to create a stand-alone Schroeder Family School of Business Administration building, to build a new University Center, and to increase the University of Evansville’s endowment above \$100 million.

The first goal was achieved in two phases, with the first completed in August 2007 when the University opened the addition onto what is now the Schroeder Family School of Business Administration building. In 2009, the second phase of that project – renovating what was the McCurdy Alumni Memorial Union into offices for the Schroeder Family School of Business Administration – was completed, giving the University a stand-alone facility for the Schroeder Family School of Business Administration.

In between those phases, the University unveiled its new William L. Ridgway University Center. Located at the center of campus, the Ridgway University Center has become the campus’s living room – home to student life offices, student publications, the University Bookstore, dining facilities, Rademacher’s Café, Ace’s Place, and the campus radio station, WUEV-91.5 FM.

Both of those facilities have since been certified as Leader-

ship in Energy and Environmental Design (LEED)-certified “green” buildings, making them the first in Vanderburgh County to achieve that designation. The Ridgway University Center also won a national design award in 2009.

“Both the Ridgway University Center and the Schroeder Family School of Business Administration building are world-class facilities that will benefit University of Evansville students for years to come,” Braun said. “Without the efforts of everyone involved in U•Envision 2010 – and especially the generosity of William Ridgway and the Schroeder family – they would not have been possible. We are extremely grateful for their generosity, and their role in offering life-transforming educational experiences to the students at the University of Evansville.”

The final goal – to raise the University endowment over \$100 million – was complicated when economic conditions lessened the value of university endowments across the nation. However, in spite of the nation’s economic woes, U•Envision 2010 has ensured that the University of Evansville remains poised to continue preparing students to engage the world as informed, ethical, and productive citizens for years to come.

manager for The Edge and Instructor of Radio/TV. "To win the Radio School of the Year in consecutive years is a fantastic achievement. Andrew Bolin, our program director, should also be commended. Not only has he done a great job of leading the station, but he has been honored as one of the best collegiate air personalities each of the past three years. Last year and in 2008 he and Kellie Orsby hosted our morning show and they won the IASB Air Personality category each of those years."

The station also has been recognized nationally by the Broadcast Education Association. Andrew Bolin placed second in air personality as part of the college audio competition. Bolin's award is the third national award the station has received in the past year.

In his role as general manager, Morris received recognition for a World War II radio drama by the Broadcast Education Association. ## USI to compete in Final NCAA II Outdoor Championship Field

EVANSVILLE, Ind.—The University of Southern Indiana men's and women's track and field teams are sending four student-athletes to the NCAA II Outdoor Championships May 27-29 in Charlotte, North Carolina.

Senior All-American Mary Ballinger and sophomore Jackie Henderson will represent the women's squad. Ballinger is slated to compete in the 3,000-meter steeplechase, while Henderson made the final cut in the 10,000 meters.

The men's squad will be represented by sophomore Dustin Emerick and freshman Michael Jordan. Emerick qualified in the 10,000 meters, while Jordan will compete in the steeplechase.

Ballinger is looking to become the first female student-athlete in school history to win back-to-back national championships. She captured the national title in the steeplechase last year when she set a school record in the event and nearly set an NCAA II meet record, finishing less than three second shy of the mark with her time of 10 minutes, 22.98 seconds.

An eight-time All-American, Ballinger ranks sixth in the 18-competitor field with her season-best time of 10 minutes, 34.23 seconds.

Henderson is making her first trip to the NCAA II Outdoor Championships, though she gained valuable experience on the national level when she competed at the NCAA II Cross Country Championships this past fall. She ranks 18th in the field with her

season-best time of 35 minutes, 51.56 seconds.

Emerick is making his second straight trip to the NCAA II Outdoor Championships after finishing 14th in the 10,000 meters at the 2009 national meet. An All-American in cross country this past fall, Emerick ranks 10th in the 16-competitor field with his season-best time of 29 minutes, 49.16 seconds.

Jordan, who competed in the NCAA II Cross Country Championships this past fall, assured himself of a spot in the 17-competitor field last Friday when he posted a USI freshman record time of nine minutes, 00.21 seconds. Jordan, who won the GLVC championship in the event and ranks eighth in the field, was just 2.21 seconds away from the school-record set by USI and GLVC Hall of Famer Elly Rono '98.

Ballinger competes in the prelims of the women's steeplechase May 27 at 6:10 p.m. (CDT), while Jordan competes in the prelims of the men's steeplechase May 27 at 6:40 p.m. The finals of the women's 10,000 meters are May 27 at 7:40 p.m., while the finals of the men's 10,000 meters are May 27 at 8:20 p.m.

If Ballinger and Jordan advance to the finals of the steeplechase, they will complete May 29 at 4:10 p.m. and 4:25 p.m., respectively. All-America honors will be awarded to the top eight finishers in each event.

## Baseball Set To Honor Seniors In Showdown With Redbirds

The University of Evansville baseball team will honor its six seniors this weekend at UE's Charles H. Braun Stadium, as the Purple Aces will entertain the league-leading Illinois State University Redbirds on "Senior Weekend" at UE. The series will begin on Thursday night at 6:00 p.m. and continue on Friday night (6:00 p.m.) and Saturday afternoon (1:00 p.m.), with the seniors being honored prior to Saturday's regular-season finale.

UE will honor seniors Alex Acheson, Corey Davisson, Keegan Dennis, Tom Heithoff, Matt Major and Andy Pascoe prior to Saturday's finale of the three-game Missouri Valley Conference series and regular-season. Combined, those six men have helped Evansville to 102 wins over the last four years while hitting a collective .290 with 65 doubles, eight triples, 12 home runs and 189 RBI offensively and racking up 22 wins and 19 saves on the mound. They have all been key contributors to UE's resurgence this season, as the Purple Aces have won 28 games this season after posting just 14 victories two seasons ago.

The seniors will hope to play the role of spoiler in the MVC title race this weekend, as UE will try to derail the title hopes of league-leading Illinois State. Evansville will bring a 28-24 overall record and 8-10 conference mark into this weekend's series, while Illinois State will counter with a 26-20 overall mark and 14-4 MVC record. The Redbirds are currently a half-game ahead of Wichita State in the MVC standings, and Illinois State needs one win to clinch a share of the title, and two wins to win the school's first-ever outright MVC regular-season title in the sport of baseball. Illinois State is led by sophomore infielder Kevin Tokarski, who will bring a league-best .448 batting average into this weekend's series.

Evansville, meanwhile, currently occupies fifth place in the MVC standings, but UE could finish anywhere from third to seventh place in the Valley standings depending on what happens this weekend.

All three games of the weekend series can be heard live on 91.5 F.M.-WUEV.

## Eagles start series action Sunday

EVANSVILLE, Ind. – The ninth-ranked University of Southern Indiana baseball team opens NCAA Division II Championship Series action Sunday at 4 p.m. against 11th-ranked Minnesota State University-Mankato at the USA Baseball National Training Complex in Cary, North Carolina. USI (48-13) is making its second appearance in the NCAA II National Championship Series, which runs through May 29.

USI and MSU (44-14) are joined in bracket two by sixth-ranked Kutztown University (41-13) and 13th-ranked Franklin Pierce (41-15-1). Kutztown and Franklin Pierce are scheduled to play the first game Sunday at noon (CDT).

Bracket one, which begins play Saturday, features top-ranked University of California San Diego (51-7), second-ranked Tampa University (46-9), third-ranked Central Missouri State University (51-9), and fourth-ranked Georgia College & State University (39-15). CMSU and Tampa start the national championship series Saturday at 1 p.m., while UC San Diego and Georgia College conclude the first day of action at 5 p.m.

Fans can follow the Eagles throughout the NCAA II Championship Series through the airwaves and the internet. WPSR 90.7 HD2 is airing the games live (radio and internet); NCAA.com are televising all of the games live through the internet; and Mount Olive College, the series host, is providing live statistics on the internet. CBS College Sports is scheduled to televise the national championship game live May 29.

Screaming Eagles Baseball Notes:

\* USI going back to the NCAA II Championship series. The University of Southern Indiana is going back to the NCAA Division II Championship Series for the first time

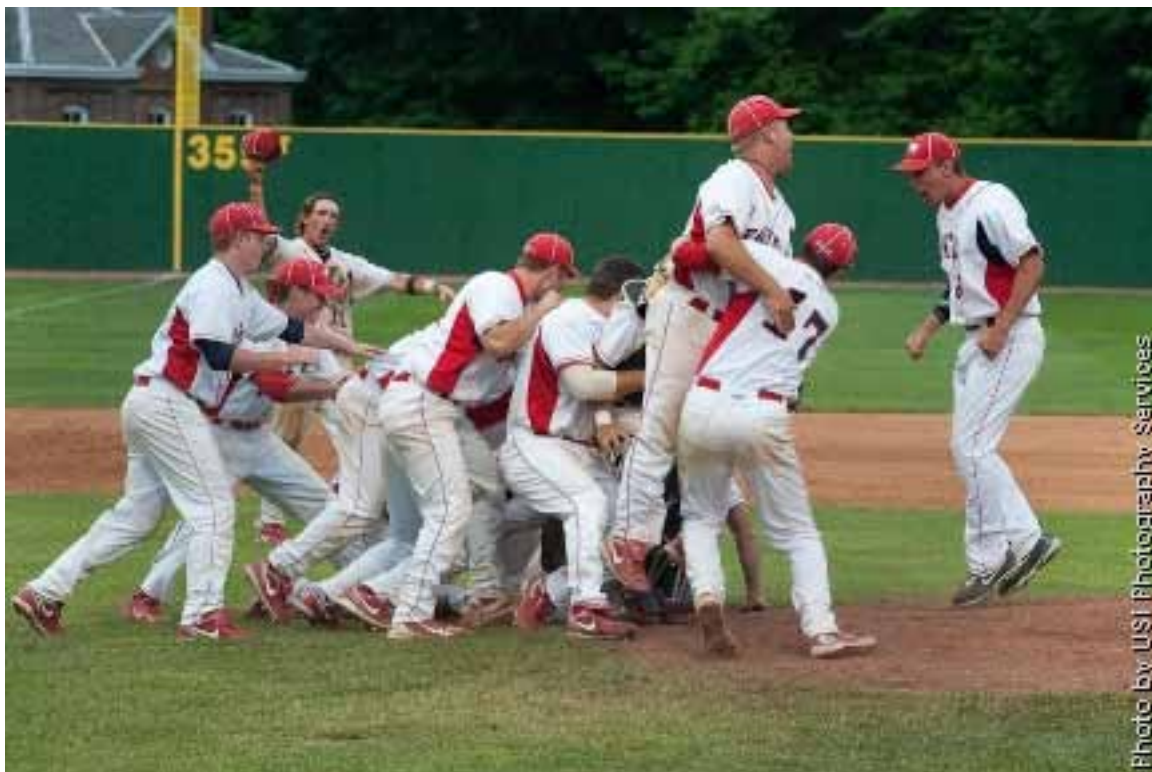

since 2007 and will be making its second appearance overall.

\* USI gets win record. The 2010 Screaming Eagles set the single-season record with 48 victories this year.

\* Eagles have been dominating. After starting the year 10-7, the Eagles have won 38 of the last 44 games, hitting .329 and scoring 386 runs (8.8 per contest).

\* Hitting the gas at the plate. The Eagles have had the hot bats during the post-season, averaging 8.9 runs per game and scoring 10-or-more runs five times in 10 games. The squad also is hitting .325.

\* Ranked nationally. USI is tied for 11th in the National Collegiate Baseball Writers Association Top 25, 12th in the Collegiate Baseball Newspaper Division II Top 30 poll, and 17th in the Ping! Baseball Top 30.

\* Eagles win second Midwest Region title. USI won its second Midwest Region championship overall and the second in four seasons.

\* Leaders in the regional. Senior third baseman Wes Fink led USI with a .435 batting average in the six games. Sophomore second baseman and regional Most Valuable Player Brad Vance followed by hitting .407 with a team-high 12 RBIs and three home runs.

\* USI wins GLVC Tournament. USI went 4-0 in the GLVC Tournament and won the conference title for the first time since 1993.

\* Leader in the tournament. Senior shortstop Wandy Rosario led the Eagles in the GLVC Tournament with a .563 batting average, while junior centerfielder Justin Blinn hit .500.

\* USI wins the GLVC West. The Eagles won the GLVC West Division for the third straight season.

\* Ties record. Junior catcher Dylan Mooney tied the single season record for home runs with his 14th of the year. Kevin Brown originally set the record in 1993.

\* Mooney and Vance battling for record. Junior catcher Dylan Mooney and sophomore second baseman Brad Vance are battling for the USI single-season RBI record. Mooney tied the former record (64), which was set by Jason Krack in 1994, with a two-run home run against Indianapolis in the Midwest Region Tournament. He surpassed with an RBI in the first inning of the championship game against Grand Valley State.

Not to be out-done, Vance tied Mooney at 65 with a three-run home run in the second inning of the championship game. Vance took a brief lead when he notched his 66th RBI of the season with one in the fourth inning. Mooney matched his teammate with an RBI single in the fifth inning.

\* Leach continues to roll. Junior right-hander Trevor Leach continues to roll on the mound for USI. Leach is

11-1 this season, 22-1 in the last two seasons, and 23-2 for his career. He needs two more wins to tie the career mark (25) set by Todd Niemeier (1992-95).

\* Honored by the GLVC. USI had seven players named All-GLVC last week before the conference tournament. Junior catcher Dylan Mooney, junior leftfielder Michael Huling, and junior right-hander Trevor Leach were named to the first team, while senior utility player Wandy Rosario, senior rightfielder Caleb Ehmke, junior centerfielder Justin Blinn, and junior right-hander Taylor Dennis earned second team honors.

\* Honored by Daktronics and ABCA. USI had three players named Daktronics and American Baseball Coaches Association All-Midwest Region. Junior catcher Dylan Mooney and junior right-hander Trevor Leach were named to the first team, while junior leftfielder Michael Huling was named to the second team.

\* Archuleta honored by ABCA. Head Coach Tracy Archuleta was named the Midwest Region Coach of the Year by the American Baseball Coaches Association. Archuleta also was named the region's Coach of the Year in 2007.

\* Honored at the Midwest Regional. USI had five players named to the Midwest Regional All-Tournament team -- Sophomore second baseman Brad Vance (MVP), senior shortstop Wandy Rosario, junior right-handed pitcher Trevor Leach, senior third baseman Wes Fink, and junior leftfielder Michael Huling.

\* Vance named MVP. Sophomore second baseman Brad

Vance was named the Most Valuable Player in the NCAA II Midwest Regional Tournament, batting .407 with 12 RBIs and three home runs.

\* Team records broke in 2010: USI has broken nine team records in 2010. The Eagles have set a single season record for wins (48), winning streak (15), hits (675), doubles (133), RBIs (452), runs (514), at-bats (2077), hit by pitch (76), and put outs (1539). The team also is on pace to break the record for winning percentage (.774, 41-12 in 1993).

## TO YOUR GOOD HEALTH

### Women Can Ignore Most Fibroids

**DEAR DR. DONOHUE:** A 50-year-old friend of mine was diagnosed with leiomyoma of the uterus. Does this have anything to do with fibroids? She has fibroids, but her doctor says they are best left alone, since they shrink at menopause. What causes leiomyoma? Can it become cancer? What treatments are available? -- L.B.

**ANSWER:** "Leiomyoma" (LIE-oh-my-OH-muh) is the medical word for "fibroid." Fibroids are noncancerous growths of the uterine muscle. The uterus basically is a muscular sack with a lining designed to nourish a fetus.

The cause of fibroids hasn't been determined.

They're extremely common. By age 35, 40 percent to 50 percent of women have one or more. By age 50, 70 percent to 90 percent have at least one fibroid. For most of these women, fibroids cause no trouble and can be ignored.

Large fibroids might cause pelvic pain, and they can press on adjacent structures such as the bladder. When that happens, a

woman has a need to empty her bladder frequently. Heavy menstrual bleeding is a sign of fibroids. They also can bring painful menstrual periods, and sometimes they make sexual relations uncomfortable. Infertility is cited as a possible effect, but infertility due to fibroids is rare.

Transformation into cancer is possible, but not probable. If a fibroid grows rapidly, that's a sign of cancer change and must be investigated. Most fibroids shrink with menopause.

Doctors can treat fibroids in a number of ways. One is removal of the uterus -- hysterectomy. If a woman wants more children, sometimes removal of only the fibroid is possible, and this can be managed in some cases with a scope and special instruments. Uterine artery embolization is a newer treatment in which a slender, soft tube (a catheter) is passed from a surface artery to the uterine artery. When it's at the precise spot, the doctor releases sand-size synthetic particles that clog the artery and cut off the fibroid's blood supply. It withers and is shed.

**DEAR DR. DONOHUE:** I don't think you will consider this a health problem. It isn't, but it is still a problem for me. It is freckles. They cover my face in the summer, and they really bother me. How do I stop them? I am 16, and freckles are ruining my life. -- L.M.

**ANSWER:** Sunlight causes freckles. In the winter, when the sun is less intense, they fade. In summer, the stronger sunlight activates skin cells to produce melanin, the dark pigment responsible for tanning -- and for freckles.

Sunscreens with an SPF -- sun protection factor -- of 15 or higher afford a good defense against the sun's ultraviolet rays. You shouldn't go outside without applying it, and you should reapply it as often as the label directions say. If you can find it, get a sunscreen with protection against both ultraviolet A and B.

A hat provides shade for the face and is another protection against freckles.

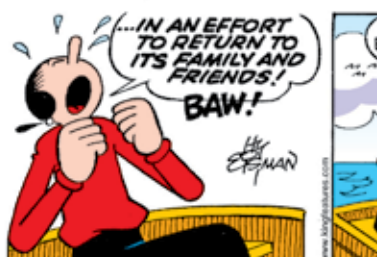
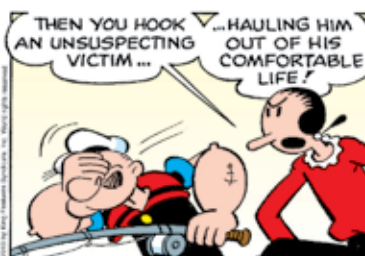
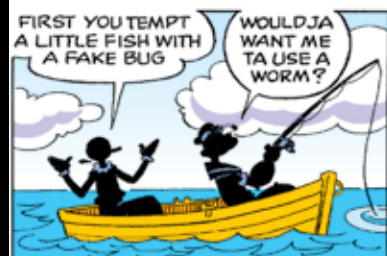
