### **Robbery – Multiple Arrests**

The Vanderburgh County Sheriff's Office has arrested five people in conjunction with a violent robbery which occurred at **Moutoux Park** at 5014 North St. Joseph Avenue. The robbery occurred between 9:00 PM and 10:00 PM on September 22<sup>nd</sup> and was reported several hours later when the victim, **Matthew Voss**, sought medical treatment at an area hospital.

Deputies interviewed the Voss who advised that he had met with a female acquaintance, **Brittany Curtis**, and her female friend, **Janice Moorman**, on the 22<sup>nd</sup>. The trio visited an area convenience store together. Voss then agreed to accompany Moorman to Moutoux Park. Curtis remained at the convenience store. Voss stated that when he and Moorman arrived at the park, three masked men, later identified as **Jeremy Wilson**, **Nicholas Reiter** and **Tyler Burnette**, approached the vehicle and pulled him from the vehicle. The three masked men beat him with their fists and unknown objects and robbed him of currency and his wallet. Wilson, Reiter and Burnette left the park in a vehicle that had been parked nearby and Moorman left in her vehicle, leaving Voss alone in the park suffering from several serious injuries. The victim Voss was able to walk to a friend's house from where he was transported to a hospital for treatment. Voss suffered multiple facial fractures as well as numerous cuts and bruises.

On September 23<sup>rd</sup>, based on information found at the scene and from the victim's statement, Vanderburgh County Sheriff's detectives were able to develop multiple suspects. An arrest warrant was obtained for Curtis. She was located at 410 SE 2<sup>nd</sup> Street Apt 5 along with Wilson. Evidence linking them to the crime was recovered during the execution of a search warrant for the apartment. The three additional suspects, Reiter, Burnette and Moorman were also located later in the day by Vanderburgh County Sheriff's detectives as well as additional evidence linked to the crime.

All five suspects were interviewed by detectives and all five gave statements implicating themselves and the others in the robbery. They were arrested and transported to the Vanderburgh County Detention Center where they are being held without bond.
