Goldstein is a veterinarian here and had an employee, use Goldstein's DEA license number to call in a prescription for 150 50mg Tramadol at WalMart on 12/10/2014. This prescription was never picked up but the name on the order was the suspect's but Goldstein's license number was used. Another prescription was called in on 1/23/15 for 250 of the same tablets with four refills. The order was picked up on 1/30/2015. Another employee was with the suspect when she went to pick this prescription up "for her own dog". The employee saw the suspect go to the bathroom after she got the pills and she thought the suspect might be taking them herself. The employee alerted the clinic to this and that is when they found she was using Goldstein's number. Dr. Goldstein stated that the suspect was given a script for 56 tablets with no refills for her dog by Goldstein. The suspect then called WalMart using a different veterinarian's name and Goldstein's license number to get the larger prescription. The inventory was checked in their clinic and a total of 963 of the 50mg Tramadol was missing. 721 of these tablets were from Goldstein's cabinet and 242 from another vet who no longer works at the clinic. She stated that he went outside in the alley near the home with her phone, where she went to retrieve the phone back into her possession. DM

DM stated that LF came back into the apartment and began to hold her a push her demanding her to give him her phone. She stated that LF punched her on the right side of her face before he exited the home. DM complained of the pain in her face. I did not observe any visible marks on her face.

DM was given a case number in reference to this incident and advised to place a Protective Order against LF.
