I observed Rebecca's nose to be swollen and crooked. I checked the bathroom sink and found blood droplets from her bloody nose. AMR responded to the scene to evaluate Rebecca. They confirmed that her nose was swollen and crooked but she refused treatment. She stated she would go to the hospital tomorrow to get it checked out.

I provided Rebecca with a case number, a notice of victim rights and a list of social service agencies to assist her. Rebecca also signed a victim notification form. I explained the process of obtaining a protective order against the offender. She advised she would go to the clerks office tomorrow with her daughter to secure the protective order.

Enroute to the VCCC, the offender notified officers that he had taken approximately 30-40 prescription pills prior to the domestic incident. The offender was taken to Deaconess Hospital for clearance. Deaconess decided to keep the offender overnight in ICU to be evaluated. Please file charges/issue a warrant for the offender.

The offender has two prior convictions for domestic battery.
