Recently a call was received there by an older male believed to be the suspect claiming he was going to blow the place up and shoot everyone inside. Numerous times over the past five months, the O'Mullanes have asked the suspect to leave them alone, but his stalking behavior continues. This is the fist time they have asked for a report by the police.
