	<p>I was stopped facing east in the roadway (in the 700 block of Taylor) when I observed a white Nissan Sentra (IN dealer tag E600767) go past me (west on Taylor to Linwood) with a temporary tag that showed an expiration of 04-12-2015. The vehicle turned north on Linwood from Taylor and immediately parked near the front of 1416 Linwood. I observed a tall, black male with short braids and wearing a white T-shirt, that I later identified as Adjani Dowell, driving the vehicle prior to parking it, saw him exit the vehicle, and, along with his white female passenger, go inside the southernmost apartment of the duplex. I checked this address in our computer system (1416 S. Linwood) and found Dowell's name associated with this address from a previous run earlier in the year. I checked Dowell's photo in RMS and confirmed he was the driver I had seen operating the Nissan. I checked Dowell's driver's status, through BMV/IDACS, and it returned showing him to be a Habitual Traffic Violator for Life. When I checked Dowell's arrest history in RMS, it showed he had just been arrested on 04-21-15 for driving while being HTV for Life. I checked the registration plate through IDACS/BMV and it returned showing it had expired on 04-12-2015 and that there was no 2016 issue plate on file for the VIN number of the Nissan.</p> <p>I advised Detective Rob Pylant of my observation and asked if he could help me watch the vehicle to see if Dowell would drive again when he thought the police were out of the area. About 15-20 minutes later, Pylant advised he saw a tall, black male with short braids driving the vehicle (with a white female passenger) from where it had been parked. The Nissan went north on Linwood, turned right (east) onto Jackson, and continued east before Dowell dropped the female off in the 800 block of Taylor. Dowell then continued east on Jackson, north on Grand, east on Adams, north on Kentucky, and east on Bayard Park Drive.</p> <p>I caught up to Dowell's vehicle at Bayard Park/Kerth, observed Dowell driving the vehicle with the expired plates, and initiated a traffic stop.
