J.B. began threatening me saying that he was going to fight me. I then asked for additional units to respond.</p> <p>I was on my portable radio running J.B. over Info through dispatch making sure he didn't have any warrants. While waiting for Info to respond I began asking J.B. what his current address was. J.B. stated to me "I live". I told J.B. that I didn't understand what that meant and that I just needed an updated address for him. J.B. stated that it didn't matter where he lived because he knew he was about to go to jail. I asked J.B. why he thought he was going to jail. J.B. stated that I knew why and nodded his head. I told J.B. that I didn't know why and asked him to tell me. J.B. then stated that he was on probation. I asked J.B. what he was on probation for and how long he has been on probation. J.B. said he just got out 60 days ago for dealing K2. I explained to J.B. I would let him leave as long as he didn't have any warrants and asked him again where he lived. J.B. said "you wanna know where I live?", I replied yes I need your address. J.B. stated I'll show you where I live. J.B. then took his hat off and threw it on the ground. J.B. was wearing a sling on his left arm, he took that off and threw it on the ground. J.B. then took his shirt off, threw it on the ground, pounded the right side of his chest with his right fist and said "that's where I live!". J.B. has "west side" tattooed across his chest, so I asked J.B., you live on the westside? J.B. stated "no nigga, I live that life!". I told J.B. that I didn't know what that meant and I still needed an address. J.B. said something along the lines of fuck you, we about to fight.
