During that time Jarrell noticed items inside bathroom had been moved including Jarrell`s purse that contained her prescription pill bottle containing approximately fifty-six 1 Mg Clonazepam pills. The OF was only in the residence a few minutes before leaving with a family member. Shortly after the OF left, Jarrell counted her pills and discovered only 32 pills remaining in the bottle. Jarrell did not report this at that time.</p> <p>This morning Jarrell accused the OF of taking the keys to her minivan and leaving in the vehicle overnight. Jarrell never witnessed the OF driving the van nor did she observe the van missing from the driveway at any point during the night. The OF admitted to taking the keys from Jarrell`s purse and getting inside the van but stated she did not take the vehicle out of the driveway. The key had been located inside Jarrell`s purse which was inside her bedroom overnight.</p> <p>The OF is allegedly 3 months pregnant and has been kicked out of her grandmother`s house and is no longer welcome at the 2517 Ravenswood address.
