The neighbors are afraid of Brian and what he may do. Fleming's neighbors to either side of his residence are afraid to walk in their yard as they may step on a syringe. The neighbors are fed up that he keeps getting arrested and released. I have been on EPD nearly 10 years myself and I have dealt with Fleming on numerous occasions and have locked him up. I told the neighbors I would look into the matter further to try and help the situation.	
	I assisted with Fleming being arrested in August and discovered he is out on bond on that case. Docket # 82D03-1508-F6-004959. I also discovered that Fleming was arrested in September, 2015, for Public Intoxication. Fleming plead guilty and was released on probation for one year after serving 3 days in jail. See docket 82D01-1509-CM-005423. It was noted as a condition of his sentence to probation that he is not to consume any alcohol and is to have daily breathalyzer tests.
