

**AN ORDINANCE CONCERNING COUNTY COMMISSIONER MEETING DATES FOR 2017**

WHEREAS, I.C. 36-2-2-6 requires that regular meetings of the Board of Commissioners of Vanderburgh County shall be established by resolution or ordinance on before the first meeting in February of each year:

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Vanderburgh County, as follows:

**SECTION 1. AMENDMENT OF SECTION 2.04.020**

Section 2.04.020 of the Code of Ordinances of Vanderburgh County is hereby amended by deleting said Section as it is presently constituted and substituting the following in lieu thereof:

**Section 2.04.020 Meetings.**

A. In accordance with I.C. 36-2-2-6, the County Executive of Vanderburgh County shall hold a regular meeting at least once a month and at other times as needed to conduct all necessary business and the dates of regular meetings shall be established by on or before the first meeting in February of each year.

B. The regular meetings of the Board of Commissioners of Vanderburgh County in 2017 shall be held at 3:00 p.m. in Room 301 in the Civic Center Complex in Evansville, Indiana on the following dates:




**SECTION 2. EFFECTIVE DATE**


This Ordinance shall be in full force and effect from and after its passage by the Board of Commissioners of Vanderburgh County and following publication as provided in I.C. 5-3-1.


