I then spoke with Payton. Payton was crying and visibly upset. I asked Payton if she took the watch. At first, Payton denied stealing the watch, but admitted to wearing it, and that Anthony has it now. I asked how Anthony got the watch and she replied she didn't know. Payton stated the last time she saw the watch, it was in Anthony's room. I asked Payton how Anthony could have stolen the watch, when Elarkian told me that he doesn't know Anthony, nor has Anthony ever been in his house. Again, Payton stated she didn't know. Upon further questioning, Payton stated that if she did steal it, she doesn't remember it, because she is a frequent narcotic user and has trouble remembering things.

I then asked Off. Hessler if he would go to Anthony's grandmother's house., speak to the grandmother, and asked if you can look for the watch. Hessler agreed and went enroute. Once on scene, Off. Hessler advised that the grandmother, Teresa, told him that the police had taken everything when they executed a search warrant at her house, on 11/11/17. The search warrant was in reference to a subject with a gun. When officers finished that run and everything was secured, a warrant was granted where officers recovered several guns, narcotics, paraphernalia, and more. See case# 17-25050.
