Officer was dispatched to 5100 Helmuth Ave in regards to a physical fight.

Officer C. Nutt and I, J. Clegg was dispatched to 2601 Adams reference a Hold up report that occurred about an hour before police were called. Officer Nutt and I both could smell marijuana inside the apartment. The Victim Stephany stated she had just arrived home from the bank after doing a withdraw of \$200 dollars. Also inside the apartment was Rachael and Chandler, Stephany son and daughter. Stephany stated she heard a knock at the side door (west door) and goes to open it. Stephany stated a black male wearing black hoody pointed a small black gun at her and ordered her to the floor. Stephany stated while on the floor she saw one other person entered inside but couldn't see them. Rachael stated she was using the restroom at the time this was going on and only peeked out. Chandler stated that there was four black males wearing all black hoodies. One of the black guys pointed a gun at him. The suspects ransacked the living room area. One of the two or four suspects grabbed Stephany purse with her cash inside and grabbed Rachael broken cell phone that was located in the living room.

While waiting on Detective Lowe to arrive, Stephany husband began walking the neighborhood and located the purse behind their house and to the east in the access ally. Officer C. Nutt recovered the purse and was returned back to Stephany. Everything was still inside the purse except for the cash.

Det. Lowe interview each separately. A case number was given to Stephany. None of the victims could recognized any of the suspects which they only got a brief look at them.

On 04/02/2018, officers were dispatched to the 1100 block of Weinbach Ave in reference to a residential burglary in progress. The RP stated that the suspect, her ex-boyfriend, kicked down her door and is not sure if he is inside the home. This call was re-opened from a previous call earlier in the night for an invasion of privacy report.

When officers arrived, we witnessed the front door forced open with damage on the outside of he door. The victim, had placed a couch in front of the door to deter the suspect from entering the home. Officers made entry to the home and made sure the suspect was no longer on scene. Once we made contact with the victim, she stated that officers had just left her home and that her ex-boyfriend had came back and kicked down her door. She immediately retreated into her bedroom and called the police. She stated that he did not enter the home. She stated once she called the police, she witnessed him running away from the apartment complex from her bedroom windows. The suspect has an active restraining order against the victim.

A report was taken and the victim was advised to leave her residence for the night. Officers further gave this address extra patrol.
