The witness observed the suspect vehicle turn north onto Walker, and then travel out of sight.</p> <p>When I arrived I found damage to a storage building as well as a GMC Jimmy behind 322 S Walker. The tracks from the suspect vehicle left the area that the Jimmy was parked through the grassy area and then into a large hole where a drainage culvert is located.</p> <p>I made contact with the resident at 322 S Walker and advised him of the damage to his property. The victim was given the case number and advised to call records if he found any additional property damaged once he was able to inspect his property inside of the storage shed. The victim told me that he believed one of his nearby neighbors had recently installed security cameras. He advised that he would make contact with the neighbor to see if they had any of the incident on video. If so, he will contact us.</p> <p>I traveled the path of the suspect vehicle as described by the victim. I located a red Chevrolet Colorado that was parked in front of 302 S Walker. The Colorado had damage consistent with what I have observed at the scene of the crash. I made contact with the resident of 302 S Walker who also advised that he was the owner of the Chevrolet Colorado.</p> <p>I asked the owner what happened to his truck and he indicated that he had no idea that there was damage to his vehicle. As the suspect spoke, I observed that he was highly intoxicated. The suspect stated that he had not left his residence, that he had not driven the vehicle, and that he had been drinking at home. I asked where the keys to the vehicle were and he advised that they were inside of his house. I retrieved the keys in order to conduct an inventory prior to towing the vehicle. The suspect stated that no one else had keys to the vehicle, and he does not allow anyone else to drive it. I explained that his vehicle would be towed and held for the hit and run unit.
