The caller reported her boyfriend had assaulted her again.</p> <p>Officers arrived in the area and located a female, identified as the victim, walking north on Fares Avenue. Officers spoke with her and observed a fresh abrasion along the right bridge of her nose, near her right eye. She also had healing black eyes. Officers learned her boyfriend, identified as the offender, had punched her on her face during an argument shortly before she called 9-1-1. During the investigation, officers discovered the offender had a prior guilty plea for domestic battery this month, May 2020, which enhanced this offense to a felony.</p> <p>Officers went to the Sunset Motel and attempted to locate the offender, but were unsuccessful. The victim safely arrived at her destination and was informed to call 9-1-1 if she desired to return to her room at the Sunset Motel in order to gather property.</p> <p>Photographs of the victim's injuries were taken with an officer body camera.</p> <p>A report was submitted to the EPD Domestic Violence Investigation Unit for follow-up. Suspect was not located at time of this report, therefore no arrest was made. If suspect is located during the shift, he will be arrested.</p>		THIRY, K. D.

<i>Violence Incident Report</i>	<p>On 05/24/2020, at approximately 07:35 hours, the Evansville Police Department (EPD) was requested in the area of Read Street / Florida Street in reference to a family dispute. The caller could not be advised on a specific location, but reported a white male and white female were arguing.</p> <p>Officers arrived in the area and located the incident at 1220 Read Street. Officers observed broken ceramic pots and dishes strewn along the walkway in the back yard. It appeared the occupants were also moving from the residence. Officers located an open back door and heard a female, later identified as the victim, speaking with someone on the phone. Officers made contact with her and observed significant bruising on her left eye and along the upper portion of each arm. She allowed officers to search the residence to ensure it was clear.</p> <p>The victim reported she and her boyfriend, identified as the offender, were in the process of moving out of the residence. When asked about the bruising, she stated the black eye was from "catching an elbow" during the move, while lowering a shelf. When asked about the bruising on her arms, she reported the bruises were from rough intercourse. When asked about the broken ceramic dishware located behind the residence, she stated the dishes had been in a box and were kicked by the offender because he was tired of carrying the boxes to the car.</p> <p>A child carseat was observed, but the child was not present. The victim stated the child was with her aunt in Boonville, Indiana.</p> <p>The observed bruising appeared to be fairly recent, within the past two or three days.</p> <p>Given the totality of the circumstances, it seemed more likely than not violence had taken place within the residence even though the victim reported otherwise. A domestic violence incident report was submitted for documentation purposes to the EPD Domestic Violence Investigations Unit for follow-up if necessary. No arrest was made at time of report.</p>
