Reported: 09/19/2020. On today's date, officers were dispatched to 1125 MacArthur Circle for a report of disorderly conduct. The reporting party told dispatch that three black males had been drinking alcohol and were now arguing and fighting. When Officer Klein and myself arrived, a male subject, later identified as Binder, was located sitting in the driver's seat of a white van parked on the street in front of 1125 MacArthur Circle. The vehicle was not running. I also observed a male passenger, later identified as Lipson, and an unidentified black female in the back seat. I approached the van and attempted to speak with Binder. I immediately observed the odor consistent with that of an alcoholic beverage emanating from Binder's person. Officer Klein asked Binder if he had been drinking today, he stated "no". Binder then stated he was about to leave. As I was speaking with Binder, Binder immediately exited the vehicle and started walking away. I gave Binder multiple commands to stop, to which he refused. Binder continued to walk away toward the porch of 1125 MacArthur Circle. I placed my hand on Binder's right shoulder and he immediately pulled away, continuing to walk towards the house. Binder then sat on the porch of 1125 MacArthur Circle. Because Binder was noncompliant, I attempted to detain Binder. I placed myself behind Binder and gave him commands to bring his hands behind his back, Binder tensed his body and flexed his arms to prevent me from placing him in handcuffs. Binder was given several more commands to place his hands behind his back, to which he refused and continued to flex his arms. I then placed a handcuff on Binder's right wrist and pulled his arm behind his back, while maintaining control of his left arm. Binder was instructed once more to bring his other arm behind his back, he refused. Force was used to place Binder into handcuffs. Binder was	TREMBCZYNSKI,

placed back into a seated position on the porch. Binder became disorderly during this time by yelling very loudly.

After Binder was secured in handcuffs, I attempted to speak with him once more. Binder became verbally abusive toward officers and asked why he was handcuffed. I explained to Binder that he refused to follow a lawful order to stop, and that he was also being disorderly. A number of neighbors had stepped outside their homes due to the commotion from Binder. Officer Klein told Binder to stop yelling, Binder continued to yell very loudly. Binder admitted he was resisting, but believed we had no right to speak with him.

I asked Binder to tell me his name, he refused. After asking multiple times, Binder finally said his name was "Tony". Binder told officers he would not provide any further information. Binder then stated he was upset about a family photo that was stolen 30 years ago. Officers attempted to explain to Binder the possible avenues of getting his photo back, but Binder continued to be belligerent. The other passenger from the van, Lipson, attempted to calm Binder down but was unsuccessful. Binder then attempted to stand up, and was immediately placed back into a seated position.

I then attempted to escort Binder to the transport wagon. Binder initially refused to walk to the wagon until his face mask was on. Officers complied with Binder`s request for his face mask, and Binder began walking to the wagon. Binder then began to be verbally abusive to officers and was threatening to "turn up". Binder continued to be disorderly as he was assisted into the wagon and transported to the VCCC.

While en route to the VCCC, Officer Klein and myself were flagged down by a neighbor. The neighbor stated that this is an ongoing issue at this address. The neighbor stated she called 911 about the same group of males the previous night due to them arguing and being disorderly.

While at the VCCC, Binder refused to let officers assist him out of the transport wagon. I escorted him down to prevent him from injuring himself. Binder began screaming "don't touch me" and also said "I'm sorry for whatever happens to your family in three or four months". Once inside the VCCC, Binder refused to let officers place a jail issued face mask on him and threatened to fight officers once more. Binder was placed into a restraint chair. Binder continued screaming profanities and racial slurs toward officers throughout the booking process.

Officers arrived on scene and made contact with the driver, identified as the offender, of the described vehicle. Officer Holden was first to make contact with the offender while the offender was still sitting in the driver side of the vehicle. Officer Holden observed the driver to be nodding off. Officer Holden found the offender to have a glass pipe, a small container of a green leafy substance, and a lighter in her hand.

Officers found two small children in the back seat of the offender's vehicle. Officers did not locate any child restraint systems for the children. The children reported that they had been at this location for approximately two hours. The children's father was contacted and he came to the scene to retrieve the children.

The offender was taken to the VCCC and booked on the above charges.

Officers were dispatched to 600 Mary St for a motor vehicle accident with injuries. An involved driver of the accident, later identified as Mayes, was driving a motorcycle when a minivan turned in front of him. EFD on scene stated they believed Mayes possibly suffered fractures to his arms and had a possible head injury. The driver of the minivan stated he was uninjured. While EFD and AMR were treating Mayes, it was discovered through an NCIC check that Mayes had an active felony warrant.

Officers Sammet and Brasher discovered through a BMV search that Mayes was operating while his license was suspended-prior on a regular ID card. The BMV search also revealed that the license plate on Mayes` motorcycle was false/fictitious. Mayes did not have current insurance for the motorcycle and has a previous conviction for operating without proof of insurance under 82D01-1801-CM-000630.

As EFD and AMR were treating Mayes, I spoke with the other driver involved in the accident. The driver, later identified as Lambert, stated Mayes told him there were drugs in his pocket. Lambert's information was relayed to Officers Sammet and Brasher as Officer Klein and I escorted Lambert to the hospital for a state blood draw. He was read Implied Consent for SBI accidents and consented. His blood test was later placed into EPD evidence.

Mayes was transported to Deaconess Midtown via ambulance. While at the hospital, Mayes was read Implied Consent and refused. At the time of this document, Mayes is currently receiving medical treatment.

While at the hospital, Officer Brasher stated he and Officer Sammet located a clear plastic baggie with a crystal-like substance and a clear plastic baggie with a green leafy substance inside Mayes` pants pocket as they were on the scene of the accident. These pants had been cut off of Mayes by EFD as they treated him on scene. I took control over the substances and transported them to EPD Headquarters to be tested.

Through my training and experience, the crystal-like substance appeared to be methamphetamine and the green leafy substance appeared to be marijuana. The plastic baggie containing the crystal-like substance had a field weight of 3.4 grams and tested positive for the presence of methamphetamine using a Methamphetamine/MDMA Reagent Kit. Officers did not witness him on the property, but quickly made contact with the OF prior to him walking back on to the listed address property. The OF continued to yell and scream at Officers while multiple neighbors exited

there homes, alerted by the incident.

Officers made contact with an elderly WI, who stated that the OF had made entry on to his property and loudly banged on his door. The elderly WI stated he was not comfortable with the male being on his property, due to his irratic behavior, and also requested him to be removed, barred, and banned from his property. Officers continued to ask the OF to settle down and stop yelling. The OF then began to yell louder and walk away from Officers. Officers commanded the OF to stop multiple times, to which he refused and continued to walk away.

The OF continued walking south, across E Parkland Ave, and attempted to make entry into the back of a residence on N Heidelbach Ave. Officers were able to place the OF in to custody prior to him alarming the residents at the N. Heidlebach address. Officers conducted a search incident to arrest and located a bottle of alcohol and a small amount of suspected narcotics in one of OF's backpacks.
