He also grabbed her by the hair and hit her head against the side of her car. At some point he also grabbed her phone and threw it across the street. The Victim stated this is a daily issue every time she has to work. She stated that her boyfriend is constantly abusive but that she has been hesitant to do anything because she does not want to keep him from seeing his son. She was given info on how to seek a protective order and how to follow up with the Prosecutors Office.
