At this time he parked his vehicle on the south side of the parking lot next to the Taco Bell sign and light post. From this parking spot, Griffin pointed the lazer on his handgun into the resturant. She stated he was pointing it at herself and Lipson. Key stated she could see the laser being pointed in through the front resturant doors. She was standing on the customer side of the cash registers. She stated the laser was visible for at least 15 seconds. Key stated that she had previous knowledge of the laser being on his gun. After he pointed the firearm into the resturant, he moved his vehicle closer to park in front of the resturant. This was the parking spot were officers found Griffin and his car.</p> <p>According to another witness on scene, a juvenile, there was a red laser pointed into the resturant. The juvenile was standing to the right of Key when the laser was apparently being shown through the front resturant doors. According to this juvenile, she did not have previous knowledge of a laser on his firearm. When I asked how she knew it was a laser from a gun, she stated it looked like something from a movie. According to the juvenile, Griffin pointed his firearm into the store, but did not present it when he came and knocked on the resturant doors.</p> <p>I also spoke with a Daniel Merry who was on scene during this incident. Merry stated that he never saw a gun or a laser. Merry stated he was standing next to the resturant door were the laser apparently was shown through. He stated he was never facing outside but heard the victim say that there was a laser from the firearm.</p> <p>Officers were able to view camera footage of this incident. No officer could discern if there was actually a laser being pointed into the resturant from Griffin`s firearm. Camera footage does show Griffin`s car in the two spots he was parked in.</p> <p>Tristate was called to tow Griffin`s vehicle. Griffin was transported to Vanderburgh County Correction Center.
