According to the run card, the shoplifter did not have an ID. Upon arrival at 19:19, we entered the Walmart Loss Prevention Office. We met with Craig Young in the Loss Prevention office where Kaitlyn was detained. I asked the shoplifter for her name, at which point she told me that her name was Kaitlyn Trainer. I properly placed Kaitlyn in handcuffs and performed a pat down for weapons on Kaitlyn. I proceeded to ask Craig questions concerning the incident. Craig explained to me that he observed Kaitlyn scanning cheaper items at the register and replacing them with more expensive items of the same type. Craig explained that he observed Kaitlyn scan the cheaper item twice and continue to place the more expensive item of the same type in Walmart bags, under-ringing the total value of the goods scanned. Craig continued to show video of Kaitlyn concealing several items underneath a less expensive item and place the concealed items in the bagging area, under-ringing the scanned items. Craig told me that Kaitlyn continued to pass all points of purchase without rendering payment and exited the store.</p> <p>I read Kaitlyn the Miranda Warning and searched Kaitlyn search incident to arrest. On Kaitlyn`s person I found a debit card belonging to Andrea Blanford, as well as a Kentucky driver`s license belonging to Tina J. Walters. When asked about the license, Kaitlyn told both myself, Officer R. Jones, as well as my partner, Officer R. Eagleson, that a friend had left the license in her vehicle. Craig told both of us that the identity found on the license was the identity Kaitlyn was using when he was filling out the loss prevention case paperwork. When asked again about the license in her possession that did not belong to her, Kaitlyn changed her story and told both myself and Officer Eagleson that her friend gave her the license, and that the friend who gave her the license was not the owner of the license. When I asked Kaitlyn why her friend would give her the license, Kaitlyn told me that her friend gave her the license "in case she needed it." I continued to ask Kaitlyn why she would need someone else`s license and Kaitlyn told me that she had previously used the license to gain entry to a casino that she had been previously banned from. When I asked Kaitlyn why she was in possession of a debit card that did not belong to her, Kaitlyn told me that the card was given to her by the card`s owner who was currently in jail. The ID and debit card were placed into found property under this case number.</p> <p>We, Officer R. Jones and Officer R. Eaglson, developed probable cause to believe Kaitlyn Trainer had committed the crime of Theft- Shoplifting under IC Code 35-43-4-2, as well as the crime of Identity Deception under IC Code 35-43-5-3.5.
