The offender finally stopped at Washington Ave and Parrett St. When officers arrived, the offender was in the drivers seat of her vehicle which was still running. She admitted to drinking. She had slurred speech and watery eyes. She had difficulty keeping her balance. She was read Indiana Implied Consent and agreed to a chemical test. She blew a 0.185 on a certified intoxilyzer. A glass pipe with burnt residue was located in her glove box. After being read her Miranda Warning, she admitted the pipe was used by her to smoke/consume marijuana.

Officers arrived in the area and met with the victim Brittany Montgomery. Brittany stated that she and Donald had gotten into a verbal argument at another location, and she had left and came to 317 Adams, which is her friends house. Brittany stated that she heard a knock on the door, and she heard Donald's voice yelling at her. Brittany stated that she then observed Donald kick in the front door and enter the residence. Brittany stated that when Donald kicked the door in, it struck her in the mouth, and knocked off a part of her tooth. Brittany stated that she then observed Donald fleeing the scene in a white ford truck, most likely headed to 711 Adams Avenue. Brittany stated that her and Donald had been in a romantic relationship for three years. Brittany was treated on scene by AMR for her injury.

Officers were able to locate a white ford truck in the driveway of 711 Adams and Donald was placed into custody. Officers read him the Miranda Warning to which he stated he understood and wished to speak to them. During a search incident to arrest, Officers located four orange pills with the imprint "1011" and "40" in his pocket. The drugs.com pill identifier app showed that it was a prescription only medication that Donald did not have a prescription for. Officers also located a clear glass pipe with residue in his pocket, which he stated that he used in order to smoke marijuana. Donald was transported to VCCC on the above listed address, and the clear glass pipe and pills were properly bagged, labeled, and dropped into evidence at the jail.
