The scratches were red and appeared fresh. One was located on the outside of his left forearm and the other was on his left shoulder. The victim stated that they were from his fiance. The victim was given a case number and informed of how to get a copy of the report. He was also informed that there were resources available to him as a victim of domestic violence. The female subject was gone upon officers arrival and was not able to be located. The female has a prior conviction for domestic battery on her fiance`.
