## ELIZABETH HALL'S PROPHETIC DISCUSSION WITH MAYOR BILL CURTIS! By: Dan Barton

Elizabeth Hall, called Betty by her friends and family, stepped up to the microphone at the Mt. Vernon Common Council's meeting of November 3rd and spoke prophetically of what was to come only three nights away, when she and her husband of 51 years, John Hall, were viciously murdered in the presumed safety of their home at 727 Mulberry Street in Mt. Vernon, Indiana.

She calmly adjusted the microphone to make it easier for her to speak and introduced herself saying, "My name's Elizabeth Hall. My husband John and I moved into Mt. Vernon four or five years ago. There are many things we're happy about."

She then went on to outline many of the things related to crime in her neighborhood which she was clearly not happy about. But she did it in a patient and clear voice that was not always picked up clearly by the deficient sound and recording system that Mt. Vernon uses. Much of the content of her message was lost to the public due to this inadequate technology. However, she said that they had added a garage door to their previously open garage, with locks on the back for security reasons. "Recently," she said, " we had a lawn mower and a leaf blower stolen out of our garage." "It happened on a Sunday, which was Halloween," she said. Two of her neighbors homes had also experienced thefts in the past

In addition, she pointed out, year. "That garage door is closed 95% of the time." Yet to her consternation and dismay, someone had nevertheless been able to ascertain that the garage contained the items they wanted to steal. The thieves were able to determine when the door was open during the remaining 5% of time, sneak into the garage without being seen and steal the equipment. This was clearly very frightening to Elizabeth, you could tell by the inflection in her voice, as can be seen and heard on ZOOM Video or on the Chanel 14 newscast that carried her discussion of that Council meeting.

Elizabeth seemed worried, but went on saying, "We're locking everything up now." "We're doing all of the things that you're supposed to do all of the time. I just don't want to move to a small town and live in fear of what people are going to do. You know what the next step that I'm thinking of at my age? It won't be limited to outside. There will be more. People will become bolder and just do more."

We could stop this story right here, given the startling and prophetic statement just made by Elizabeth Hall. It still sends me chills. As a matter of fact Mayor Curtis could also have interrupted Betty and called on the Police Chief Anthony Alldredge to address the overwhelming crime problem that is terrorizing many of the innocent citizens, like Elizabeth and John Hall, in Mt. Vernon, but he didn't, and Elizabeth went on. "Is this a trend that's happening? Are the police seeing more in the city of Mt. Vernon? We have no doubt that people are watching because of the small percentage of time that that garage door was open. Think about this. We have two cars in that garage. It wasn't like a half empty garage. You couldn't see in it if you were just walking by. We're concerned! We are now looking at getting a security system. We are now looking at having lighting on the back of our house. We always leave our front porch light on and we have a light at the sidewalk. We've always had them on. All the time. "

"My husband and I are concerned that people are watching. People are watching!"

"They stole a decorative sign off the front porch. They had to come to our porch to see it. You couldn't see it from the sidewalk of our walk coming to our house. So they were on our front porch!"

Elizabeth Hall was warning of a catastrophe that was very shortly to take place if something wasn't done to stop it. Nothing else! She was not simply talking about petty crime.

Concern, was the word Elizabeth Hall used most, but frightened would have been another word that could have worked just as well or better. She was clearly frightened and you could tell by her demeanor at the speaker's podium. However, that did not seem to be the impression that Mayor Bill Curtis came away with. He seemed to be more interested in debating the terminology Elizabeth Hall used when she politely asked whether Mt. Vernon was going into a criminal "trend". Here is Mayor Curtis' response to Elizabeth's questions in her statement to him:

"I've worked in the courts everything else - (Youth Programs, Evansville). That's what I started doing over 40 years ago. There seems to be - and the Police Chief (who was in attendance) can correct me. (Curtis looks and motions toward the Mt. Vernon Police Chief Anthony Alldredge during the meeting)

"I see cycles, not necessarily a trend; where it just keeps going up. But it depends on who moves into the area of just a few people and then things will go up. If the police are able to catch them. Then it stops.

"So, and I'm not saying that the numbers haven't recently gone up in your area - they obviously have. But it kinda comes and goes. ( Mayor Bill Curtis apparently did not have a grasp of just how bad things had gotten in his town, but according to Posey County Sheriff Tom Latham, drug arrests in Posey County have more than doubled since 2019. Mt. Vernon Detective Korben Sellers has reportedly said that, "They are probably stealing this stuff to support drug habits." The man arrested for this crime was a long term Cocaine user)

"The other thing I would like to say is, as you said yourself, Haubstadt is smaller than Mt. Vernon. I don't know that you can find anyplace where some of these thefts aren't occurring. That doesn't preclude additional (Curtis motions toward Police Chief Alldredge in the audience) patrols. I'm not saying not to do anything about it - if again - if the people have those things happening they do need to report it so the police can put additional patrols out. That may not have reassured you, but..." While Mayor Bill Curtis was fuzzy on the crime stats in Mt. Vernon, and Police Chief Alldredge made no public statement at the November 3rd meeting, here is what:

### OTHERS ARE SAYING -

Posey County Prosecutor Thomas Clowers publicly stated that 222 cases out of 578, filed in his office so fare in 2021 involved drug charges. He says that people often make bad decisions because of drugs. He believes that if people weren't under the influence of drugs they wouldn't commit some of these crimes. He estimates that that is the case 90% of the time.

Although, little has been said so far by Chief Alldredge, his Public Information Officer Caleb McDaniel has said a great deal regarding crime in Mt. Vernon. McDaniel has been a police officer for five years and this is what he has learned according to exerts of some of his public statements.

"...the root of this problem is poverty." "It's this generational problem..." "They've said that drug addiction is a form of mental illness. How do we expect this not to happen?" "My job is not to run a smear campaign on offenders. My job is to show the community that our police department is working for them and with them."

#### What say you, Chief Alldredge?

#### RESISTING COVID TYRANNY By: Richard Moss, MD

The following statement was sent to me and other members of the medical staff at a local hospital in October 2021 by its Executive Committee after approval at a Medical Staff meeting:

"In early September, the Federation of State Medical Boards, as well as the American Board of Family Medicine, American Board of Internal Medicine, and American Board of Pediatrics, issued a statement about vaccine misinformation. They stated that providing misinformation about the Covid - 19 vaccine contradicts physicians' ethical and professional responsibilities, and therefore may subject a physician to disciplinary action, including suspension or revocation of their medical license.

In support of this position, the Medical Staff voted to issue the following statement:

We believe that distribution of COVID - 19 vaccine misinformation by a physician or advance practice provider via any means is contrary to the known science and the best interests of patients. Such conduct is also inconsistent with our standard and those practitioners may be subject to Medical Staff action..."

It is no small thing to imperil a physician's livelihood, practice, medical license, and family over differences of opinion regarding optimal treatment for a particular condition. That, however, is precisely what this hospital and medical staff through its Executive Committee has done. Specifically, they threatened physicians with "disciplinary action including suspension or revocation of their medical license" for the crime of "[distributing]...Covid - 19 vaccine misinformation."

There are intense debates surrounding the vaccine, its efficacy, how long the immunity lasts, particularly as the virus evolves, its experimental nature, its "Emergency Use Authorization," and its serious side effects and adverse reactions, including death, that have been well documented. Many who have already been vaccinated still contract and spread the virus and fall ill from it. Tens of millions of Americans, previously infected, have "natural immunity," which is far broader and more durable, and do not require the vaccine. The recovery rate for patients under seventy and in good health is 99.95%, better than the flu, and many choose not to get the vaccine for varying reasons, including

risk-benefit analysis, concerns over potential complications, religious and medical objections, or personal choice. Patients under age 18 have far more risk from the vaccine than from Covid, for example. There have been some 17,000 deaths attributable to the vaccine, of all ages, but many believe that the numbers are much higher, even as much as 150,000, along with other serious complications such phenomena, as thromboembolic myo-endo-pericarditis, menstrual irregularities, stroke, myocardial infarction, and others.

Further, the various vaccines are not "vaccines" as commonly understood but "gene therapy," mRNA platforms that insert themselves into our DNA. They then harness our own cellular machinery to produce the famous "spike protein" to be distributed throughout the body eliciting the immune response, but sometimes with devastating consequences, as we have learned. A vaccine generally takes 4-6 years of development before being released and that for the Covid vaccine to have come out in just a few months meant bypassing the usual safeguards that serve to protect the public before a new drug or vaccine is brought to market. Further, the principle of "bodily integrity" or "bodily autonomy," or the right to do what we wish with our bodies (within reason), is settled law in this country based on a number of Supreme Court decisions, including Cruzan, Griswold, Casey, Loving, Rowe, and others. Beyond that, the right to one's own "personhood," the right to the possession and control of one's own body and person, free of restraint or interference, including the right to breathe freely and unmasked or the right to choose not to receive a medicine or vaccine, is as foundational as the right to life, liberty, and the pursuit of happiness. The right to self-govern and the freedom to choose is implied in our constitution and, hence, a constitutional right. Beyond that, it is a God-given, natural right.

There is also much discussion about the optimal treatment for Covid, the use of therapeutics, and the questionable logic of mass vaccination, particularly, of a "leaky" vaccine, in the teeth of a pandemic. Such an approach may select out for a "super bug," highly transmissible, that easily evades the uniform and less robust immunity derived from the Covid vaccine. Science evolves swiftly as new data and research arrive, even on a daily basis. What may be "science" or "truth" one day may be found incorrect and false the next. Further, the issue of Covid, lockdowns, school closures, masks, and the vaccine itself have become heavily politicized. "Science" has been harnessed in some quarters to pursue a particular political agenda; hence, it is not "science" so much as "political science."

All of this is to raise the question: What, exactly, is "misinformation," who decides, and who is responsible for "distributing" it? We may, with time, be surprised at the answers to these questions. Perhaps, we will find that it is the large pharmaceutical companies and their allies in government, the media, and elsewhere? Is this essay "misinformation?" Will my privileges and license be revoked for writing it?

This "statement" threatens and intimidates those who may disagree with the received wisdom from the public health and medical establishment. It silences free and open debate regarding best practices for Covid, including the use of the vaccine, even when there is legitimate It chills honest disagreement. discussion and sincere, worthwhile professional exchange and differences This "statement" of opinion. suppresses healthy skepticism, discourages counterargument,

quashes dissension, critical in a free society and for the scientific enterprise. It leads to outright censorship and intimidation of authentic interlocutors who differ in their medical opinions. It represents, therefore, an attack on free speech and our First Amendment. It is an assault, as well, on reasonable scientific inquiry and examination. It is, in a word, tyranny.

Hence, it is unwise, unsound, and unscientific. It is also unconstitutional and un-American. It is unworthy of the medical profession, the scientific process, and this great nation. It should be repealed immediately.

I communicated in writing these identical sentiments with the President and other members of the medical staff, executive committee, executive team, and board of directors. There has been no response nor did I expect one. They have already indicted themselves with their "statement." They are complicit with evil and unlikely to alter their position.

The Public Health and Medical establishment and their allies in government and the media have done horrendous harm to the nation with 19 months of "misinformation" and disastrous policies, including the lockdowns, school closures, quarantining, and mask and other mandates, none of which had any effect on the trajectory of the virus. Instead, they have inflicted enormous

Baked Havarti Galette w/ Apples - Appetizer Serves 6-8

So New Years is coming up, and I thought I would share one more of my favorite appetizers with you. This appetizer is called a Baked Havarti Galette. In short, it's baked cheese in bread. What is better then hot cheese baked in a buttery soft bread? Now we're going to take this to the next level by spreading this hot savory bread onto a sweet, crisp apple slice. Yum! Very simple, very delicious.

#### **Ingredients:**

1 can of Crescent Rolls 8 oz. Havarti Cheese, cubed 4 apples, sliced

#### **Directions:**

\*Preheat oven to 350

\*On a sheet Pan or baking stone, press out your crescent rolls flat into one solid sheet. (your shape of choice)

\*Dice up your cheese cubes into 1" cubes

\*Add cheese cubes to the central area of the pastry, leaving 2" all around open.

\*Now fold the extra 2" of pastry up over the cheese, leaving the center exposed / open faced

\*Place on the bottom rack in the oven \*Bake at 350 until golden about 10-15 minutes

\*While baking, slice your apples into wedges

\*Place the baked cheese on a serving platter, now garnish your appetizer with the apple slices all around. \*Serve immediately
