At this time the suspect reaches down and throws a snowball at the Victims house. It appears he is yelling at the Cundiff house. As the suspect is walking towards his own house he stops, picks up a rock and throws it at Mr. Cundiff who was standing outside. Mr Cundiff heard something but doesn't know what and he can find no damage.
