JULY KUSTURIN MURDER TRIAL DELAYED! By: Dan Barton

Sometimes, I hate it when I'm right! In last month's New Harmony Gazette, I announced the dates that Circuit Court Judge Craig Goedde had set for the upcoming July double-murder trial of alleged murderer Austin Kusturin, who was arrested for the crime in November 2021.

I said, "If Posey County practices run true to form these dates are purely suggestive and will probably never be realized." I added, "These July, jury trial dates are most probably a fiction, and don't even exist in the minds of any of the court officers engaged in this case." Well, I was right! Imagine my dismay, but total lack of surprise, when I recently checked the Posey County Circuit Court records and found that, indeed, after I released the February 2022 edition of the Gazette, a delay had been approved by Judge Goedde.

On January 31st, Defense Attorney Glenn Grampp filed a motion in Posey County Circuit Court for a Continuance (delay) of the Kusturin trial, which was originally to begin on July 6, 2022. Grampp was granted his requested delay by Judge Goedde and the opening date of the trial was moved up to start on July 11, 2022. There was no objection to this change by County Prosecutor Thomas Clowers. There was no specific reason given as to why Grampp asked for the delay.

As a follow up for the New Harmony Gazette's coverage on this case, I emailed Prosecutor Clowers and asked him what Glenn Grampp's reason was

for asking for the delay. Clowers emailed me the official court document filed by Grampp which indicated simply, "A conflict with prior commitments up through July 5, 2022." Since that did not encompass July 6th, I decided to once again to try to get a further clarification of Grampp's reason for the delay. I re-emailed the Prosecutor, saying, "What was the conflict that Mr. Grampp had that caused such an urgent course of action by him? That is what I'm asking concerning the reason for the change in dates!"

Clowers responded, "Unfortunately, I am not aware of his scheduling conflict — I just know it was represented by Mr. Grampp that he had a scheduling conflict that prevented him from starting the trial the week of July 6th. Based on that representation it was agreed the trial would begin July 11th instead."

Not being satisfied with Prosecutor Clowers' explanation, I emailed him again, stating, "Yes. But the document that you sent me at the New Harmony Gazette, called "Verified Motion and Reschedule Trial Date", indicates that, regarding the request for change, "... the State (Prosecutor Clowers) has no objection." No objection and no questions!

I reminded the County Prosecutor that the double murder in November 2021 was probably the most serious case of violence in almost 150 years, and,"...wouldn't it be reasonable for the State and the Court to know the specifics of Grampp's conflict before agreeing to his request. Why then did you not object to this vague motion by Grampp. I believe the people of Posey County deserve to know all of the particulars about this arrangement. This is not, and should not, be handled as a domestic dispute case. What was Grampp's specific conflict of interest that caused him to request the trial cancelation and why did the court and state not request to know the details?"

Once again, Prosecutor Clowers' answers with a reply that seemingly tries to dodge my question. He says, "Mr. Barton — this case is of utmost importance to my office and is being handled as such. Due to the nature of this ongoing criminal investigation, I am unable to provide you with reasons certain strategic decision are made. I hope that what I was able to provide you with has been helpful." Not quite, I'm afraid.

We still don't have the details or excuse of why such an important case was put on the back-burner by a vague request by the Defense Attorney. Obviously, he would get his delay no matter what, but it's no skin off anyone"s nose for the Prosecutor to ask why. As far as Clowers' excuse that by asking for the reason why, it somehow jeopardizes an "ongoing criminal investigation," that's pure hooey. The murder charges have been filed, the alleged killer has been arrested, jury trial dates have been assigned; it would seem ludicrous that the Prosecution would not be ready without some more investigation while the defendant has already been incarcerated on the murder charges.

We still don't have, and never will have, a true answer as to why Prosecutor Thomas Clowers was inclined to hold his tongue in the Hall of Justice! No doubt, there will probably be another delay coming down the pike if the court officers operate as usual!

Please, let this trial begin!

THE ARREST OF ROBERT MCCARTY FOR DEALING METH! By: Dan Barton March 2022

As promised, here are the details of the arrest of Robert McCarty of Mt. Vernon, Indiana. Robert McCarty was named by Austin Kusturin, at the time of Kusturin's arrest on double murder charges, as one of the two individuals that had sold him the cell phone that was traced by police to murder victim, John Hall, in the November double murder of John and Elizabeth Hall.

McCarty was subsequently arrested on January 19, 2022, by Indiana State Police on unrelated charges of 1) Dealing in Meth, a Level 2 Felony; 2) Possession of Meth, a Level 3 Felony; 3)Unlawful Possession of a Firearm by a Serious Violent Felon, a Level 4 Felony; 4) Possession of a Controlled Substance, a Level 6 Felony; and 5) Maintaining a Common Nuisance — Controlled Substances, a Level 6 Felony.

According to Posey County Prosector Thomas Clowers', Indiana State Police reported that McCarty was arrested for possession of approximately 190 grams of meth with the intent to distribute the illegal narcotics. The Probable Cause Affidavit said that while law enforcement while Indiana State Police were executing a search warrant on McCarty's residence and vehicle, they located the suspected meth and over \$7,000 in cash.

During the search of McCarty's residence, officers also discovered and seized a Hi-Point .45 caliber rifle. According to court records, McCarty is unable to lawfully possess firearms due to being classified as a serious violent felon as a result of a prior conviction for dealing meth.

If convicted as charged, McCarty faces 10 to 30 years in prison under Indiana law, plus a fine up to \$10,000.

Posey County Prosecutor Thomas Clowers also charged McCarty with the Habitual Offender Enhancement, which is based on McCarty's prior criminal history and could add an additional 6 to 20 years to any sentence.

McCarty is currently held in the Posey County Jail on a \$1,000,000 surety or \$100,000 cash bond.

A preliminary plea of not guilty was entered on behalf of the Defendant on January 24, 2022.

A Status Hearing is scheduled for March 30, 2022 with Judge Craig Goedde.

All persons arrested are presumed to be innocent until proven guilty in a court of law.

He was sentenced to two years prison with Indiana Department of Correction by Judge James Redwine for that crime against an eight year old girl, and was released from custody after serving one year of that sentence. Then rearrested on a separate child molestation charge in 2020.

It's been awhile since The New Harmony Gazette has said or reported anything to do with the bridge. It's still closed, as all of you know. I rarely hear anything from any of the Commissioners, but I still keep tabs.

The last time I spoke to anyone about the bridge was in November 2021, when I happened to run into Bridge Authority Chairman Rod Clark. He was putting up festival signs. I didn't press him, but I did mention that there hasn't been any news from him about the federal grant application that they filed in March of '21. On this particular day, November 15th, he said that they hadn't heard anything from the feds. I asked how much he thought the grant might pay if the Authority got the whole thing; was it ten or fifteen million, I asked him. He didn't know how much the grant was for, he said.

The next day, November 16th, I heard that Bridge Commissioner Lora Arneberg spoke at the monthly Town Council meeting and she affirmed Clark's information, saying, that the Authority was still waiting to hear on the grant funding.

On November 17th the feds announced that the grant funding had been awarded to a project in Dunes Park, in Northern Indiana. It was something over 18 million.

A short time later I ran into Bridge Commissioner Ron Eimer and he confirmed Lora's remarks as true. The Bridge Authority did not get the grant.

This is the second time in as many years that the Authority was left out of the grant award. The year before the grant went to an Indianapolis project to add a lane to one of their highways.

Now, just the other day, one of my friends in New Harmony passed on a news article from The Navigator in Illinois. It was written by Len Wells, whose been following the bridge plan development all along. People in Illinois are anxious for the bridge to reopen, just like people in Indiana. Let the commerce flow.

Mr. Wells' article, in part, says, "During a meeting Friday (December 18, 2021) of the Illinois New Harmony River Bridge Authority and the Indiana New Harmony Wabash River Bridge Authority, officials were informed that their application for a RAISE grant had been rejected. RAISE is an

Officials suggested the grant application was rejected because the bridge project was not a "shovel ready" project. "

Illinois Bridge Commissioner, Ellen Schanzle-Haskins spoke about the next step in their effort to find funding for the bridge. She said, "We want to have a meeting with the Illinois Department of Transportation and Senators Durbin and Duckworth. We need to put in a request for money to complete Phase 2 of the engineering. If we can get the funding through IDOT or the Governor's office, we can finish the engineering study and the project will be shovel ready. We can't let this project stall at all. The completion of Phase 2 will tell us exactly what needs to be repaired and where. When they are ready to hand out infrastructure funding, we are ready."
