The victim and offender continued to physically strike each other. The victim's brother attempted to mediate the situation.

> The victim mentioned hearing two males walking by and telling the offender to leave her alone. The victim stated the offender only stopped striking her when the victim's passenger (witness) exited the vehicle. The witness yelled for the offender to stop the assault. The victim was then able to leave the area in her vehicle.

Officers attempted to contact the witness of the vehicle without success.

The victim had corresponding bruises on her body. The victim stated she was getting a CAT scan done for her head pain. The victim was given a case number. She was also provided with domestic violence resources and victim's rights.
