Offender 2 picked up a pair of \$80.00 frames, removed the price tag and both lenses, and then walked up to the counter. Offender 2 told the staff that she had paid for the glasses and needed new lenses in them. Offender 2 never left with anything; however, this is attempted theft by deception. The reporter advised that both have been clients since the early 2000s and provided me their information (name, address, and phone number). I traveled to 1916 Garvin Street, where both were allegedly living. I made contact with offender 1, who advised that she did take the glasses but thought she could due to her insurance. I made it very clear that taking glasses from a store without paying for them is not how insurance works. She advised she messed up and would not do that again. I retrieved both pairs of sunglasses from her and returned to Ridgway Eyecare. Upon arriving, I provided the stolen glasses back to the reporter. The reporter did not wish to press charges and only wanted them barred/banned from the property for life. The reporter was provided a case number for her reference. I checked a couple nearby trash cans and dumpsters but I was unable to locate anything. I was unable to develop any leads with the store's security cameras.
