She states that she arrived home on 5/10/2022 to find that her home security cameras had been unplugged and that her husband's clothing was newly visible around the house.

Victim states that she and her friend, the witness, were both sleeping inside the address on today's date. Victim states that she awoke to find her ex-husband inside the bedroom where she was sleeping. The suspect became irate and threw some things around, causing damage to a dresser and wall inside the home. The victim states that the suspect never threatened her or physically harmed her. The suspect then exited the house and got into a grey minivan that was parked out front. The victim has security footage from the front porch of her house. This shows the suspect arrive in the van and enter the home. He then leaves shortly after. The witness told officer that he had locked the newly installed door handle on the front door prior to going to sleep. A noticeble footprint on the door was photographed by officer with bodycamera. No new damage to the door frame was observed.

The suspect called dispatch and requested to speak to an officer. Officer spoke with him over the phone while body camera was activated. The suspect told the officer that he was aware of the PO but had been told by his lawyer that he could go to the house if the victim was not home. The suspect stated that he had been staying at the house. When officer clarified this statement, the suspect stated that he had actually been staying at his father's house since the separation. He stated that he had been staying at the victim's home for the past few days. The suspect stated that on today's date, he arrived at the address and saw a Ford Fusion parked in the driveway. The suspect said that he knew this car belonged to the victim. The suspect said that he then went into the house. He states that he was upset and should not have gone in to the house.
