Officers were dispatched to the listed address in reference to a suspicious circumstance to the listed address. Dispatch advised that the maid had reported that there was alot of blood in the room when she cleaned it earlier. Officers then knocked on the door to the room to check the welfare of the tenants. Derick Davis then opened the door and officer could smell an odor consistant with burnt marijuana emitting from the room. Officers then called the occupants out of the room. The first to exit was Davis, then Xavier Thompson exited the room. I then observed two females in the room and asked them to exit as well. I then observed the first female, who gave a name of Sarah Moreno initially but was later identified as Brittani Meredith, grab a baggie and cigarettes off of the table before exiting the room. I then asked Meredith what she had grabbed off the table and she stated cigarettes. I then asked what was in her other hand she then dropped the large baggie of a white rock substance. I then placed her into custody. The other female that exited the room was identifed as Amber. The other assiting officers then placed the other subjects in to custody as well.

Officers then mirandized all the subjects. I then spoke with Brittani who was still claiming to be Sarah at the time. Brittani stated that she just grabbed the bag out of instinct trying to hide the illegal substance from officers. Brittani denied owner ship of the bag or any other narcotics that may be found in the room and stated that she was just visiting Derick. I then spoke with Amber who stated that she had came with Brittani. I then asked Amber who Brittani was and she claimed it was the other female we had just talked to. Amber also denied any owner ship of any narcotics or anything else in the room. I then took Amber back out side with the rest of the subjects. I then began to talk with Brittani again and called her by Brittani and she answered. I then asked Brittani why she lied to me and she claimed she might have a warrant and gave her real name Brittani Meredith. Officers ran her and found she had a felony warrant as well.

Officer Tevault spoke with Derick who was the renter of the room. Derick consented to a search of the room and several other narcotics where found in the room along with paraphernalia. Derick , Xavier, Brittani was transported to VCCC on several narcotic charges. Amber was cited and released for visiting a common nuisance.
