After the collision, Fyler said the suspect vehicle then fled north through the parking lot and east on Morgan Ave without stopping to exchange information. Fyler said she ran after the vehicle and was able to obtain a few pictures of the suspect vehicle as it fled. There was damage to the right, rear side of Howard's vehicle. There were pieces of a broken right taillight from the suspect vehicle on the ground near Howard's vehicle.		
	Howard was inside Taco Bell at the time of the collision. Neither Fyler nor Howard were able to identify or describe the driver. I reviewed security camera video from Taco Bell. The video shows the suspect vehicle pull into a parking space facing southwest (closest to the front doors of Taco Bell). A black male passenger exits briefly, pulls on the front door handles to Taco Bell, and returns to the vehicle after realizing the doors were locked. The vehicle then backs out in
