Reported: 12/11/2022.</p> <p>While I was on a routine patrol going eastbound on Washington Ave passing the intersection with S Kentucky Ave, I observed the above, black color Kia Sorento in front of me heading in the same direction. The above vehicle only had right plate light working and the plate was not fully illuminated and was unreadable. I proceeded to initiate a traffic stop.</p> <p>I approached the vehicle from right passenger side, and made contact with the driver, the IO and the driver's side rear passenger, the offender. I was able to smell strong odor of marijuana coming out of the vehicle, and proceeded to ask the occupants if there was any weed/marijuana in the vehicle. The offender stated that he had smoked some weed earlier. Once assisting officer arrived at the scene, I first asked the offender to step out, and when he exited, he had strong odor of marijuana coming out of his person. I proceeded to place the offender under arrest, and searched him incident to an arrest, and found a clear baggy with green leafy substance in it and two brown color paper rolled burned blunt ends out of the offender's left pant's pocket. Based on my training and experience, I immediately recognized the green leafy substance as marijuana. During the search of the vehicle I also found a used syringe and two electronic scales inside a small white backpack which was full of makeup. The syringe had white powdery substance around the tip of it, but was not loaded. I proceeded to detain the IO. While I was still searching the vehicle, Officer Adams read both subjects Miranda warning.</p> <p>Once I was finished with my search I escorted the IO to the front area of her vehicle and asked her if she was clear on her rights and would like to talk to me, she stated yes. I asked her about the drugs that she uses, and she admitted using marijuana and methamphetamine. I asked her if she smoked or used syringe for methamphetamine, the IO stated smoking. The IO stated that she just dropped off her female friend, and that they share her backpack full of makeup, and she was not aware that she had left the syringe in it, she refused to provide the friend's name.</p> <p>The offender was cited and both subjects were released at the scene.</p> <p>Later at EPD west sector office I used Nark 2 narcotics test kit to test the green leafy substance and it tested positive for THC and had total field weight of 8.12 grams. I tested the powdery substance off of the syringe's tip for methamphetamine, but it tested negative. I properly discarded the syringe in a hazard box.</p>	AGHASARYAN,
