Officers were dispatched when the male was slumped over behind the wheel and the vehicle was smoking.</p> <p>Officers arrived in the area and observed the vehicle. The vehicle was running and officers could hear the engine revving, seeing smoke coming from the back end. Officers walked up to the vehicle and observed the driver slumped behind the wheel and his foot on the gas. Officers attempted to open the door to the driver side of the vehicle, but there was no door handle. Officers then began to pull down on the window, when the driver awoke. The driver was told to turn off the vehicle and step out. Officers got consent to search the male's person and had him step back to their marked police vehicle.</p> <p>Officers were originally lied to by the driver about where he was coming from and when officers went to get consent to search the vehicle, the driver stated there was "weed" in the vehicle. The driver was placed in handcuffs and officers searched the vehicle.</p> <p>During the search officers located to pipes with burnt residue, a digital scale with residue and .37 grams of a green leafy substance. The green leafy substance later tested positive for marijuana using NARK II test 05. All was collected and later placed into evidence.</p> <p>Officers determined the male was okay to drive and he was give/explained his citation (8220169645).
