Reported: 04/20/2023.</p> <p>Officers were dispatched to an assault in progress.</p> <p>Deputies arrived in the area and observed two females yelling at a vehicle in the drive thru line of Taco Bell. Deputies stated the line was beginning to wrap around the building as the two females continued to scream at the driver of the vehicle. The deputy placed the two in handcuffs.</p> <p>Officers arrived on scene and told the females to lower their voices multiple times, but they continued to yell and speak over officers. Officers could smell the odor of alcohol coming off their persons` as they continued yell. Officers had the deputy stand with the females (one adult and one juvenile) and they went inside to talk to the employees.</p> <p>The employees stated they were extremely busy, as the two females were found in the bathroom drinking. One employee got a call from his boss asking why the lines were getting so long (boss was watching the cameras). He explained the situation and was told the two females were to be fired. He walked up to the two highly intoxicated females and showed them that the boss called. He told them they were fired. The adult female began to grab two of the employees as they were telling them to leave. At one point, one of the employees locked the front door, locking the other employee and two females outside. The adult female began to push on the employee that was outside before he was able to get back into the building, relocking the doors.</p> <p>Officers went back outside and heard the females still screaming. They were told to lower their voices again. The adult female attempted, multiple times, to stand up and walk away, but was placed back on her buttock. The juvenile female slipped out of her handcuff and tensed her body up as officers were attempting to put her in handcuffs. Both females blew in a portable breathalyzer. The adult female blew a .208 and officers were unable to get a reading from the juvenile because she could not follow directions.</p> <p>Once officers were able to switch out handcuffs on the two females, the females were searched incident to arrest. Officers located a brown paper with green leafy substance in the juvenile`s back pants pocket. Officers later searched the juvenile`s bag, locating more of the brown paper with green leafy substance. There was also a small corner baggy with green leafy substance. The total amount weighed 2.3 grams, later testing positive for marijuana using NARK II test kit 05.</p> <p>As officers were attempting to search the adult female, force was used to gain compliance and search her person. She was searched and placed in the back of the transport wagon, where she refused to sit down. The female was made to sit down. During the process, she threw an elbow striking an officer in the face, while they were engaged in their lawful duty.</p> <p>The juvenile female was taken to YCC after receiving jail clearance.
