The driver then stated his name was Scott Dockery. Officers then asked for his date of birth to which he argued was on the insurance slip. The driver then started to say his birth month was September, then stopped answering. Officers asked "September what?" The driver then stated "I don't know, that's my uncle's paperwork." Officers know from past training and experience, this statement is indicative of a False Identity statement and a Refusal to Identify for a traffic violation. Officers requested another unit to assist. Officers then ordered the driver to exit the vehicle. The driver argued with officers as to why he needed to exit the vehicle. The driver appeared to be reaching for the gear shift. Officers again ordered the driver to exit the vehicle or he would be removed. The driver again refused to exit on his own free will. Officers then used the necessary amount of force to effect the arrest. Once the driver was placed in handcuffs, all force ceased. The offender then identified himself as Dereck Evans. Evans stated he thought he had a writ of attachment. Officers checked Evans' driving status through the BMV which showed he had never received a license and only obtained a Regular ID card. Evans did not possess any valid warrants. The vehicle was towed by Tri-State Towing.
