Officer

Officers arrived to the residence and located the victim sitting on the front porch. She stated the offender pulled her hair and it was still hurting her. She stated he was still inside the residence. We located the offender in the bathroom, placed him in handcuffs without incident, and took him to the backyard.

I read the offender his Miranda Warning, he stated he understood, and he was willing to talk. He stated he has been going to therapy and not wanting to talk about it to his wife. She kept trying to speak with him about it and that's what got the argument started. They have three shared children. He keeps all of their social security cards in his wallet. The victim was requesting the cards and he told her she could not have the kids cards. She got into his back pants pocket and retrieved the wallet. In the struggle to get his wallet back it got physical. He stated she bit him on the hand in the altercation. He had a cut on his right thumb consistant with a bite. He stated they have been married 16 years and have three shared children.

I spoke to the 15 year old juvenile (involved other). He stated he was in his room and could hear his mom yelling for him. He entered the room and saw his mother on the ground. He saw his father leaving the room and going into the bathroom. The victim asked the juvenile to call grandma that lives next door (reporting party).

I spoke with the victim on the front porch of the house. She stated she got into an argument with the offender about mental health issues. She told him that maybe it's best he move out of the residence. She stated she asked for the kids social security cards and when he wouldn't give them she grabbed his wallet out of his pants pocket. The offender grabbed ahold of her hair and wouldn't let go. She did not have marks that I could see under her hair, but she had a complaint of pain that lasted through our conversation. She stated she turned away from him and was facing the opposite direction. I asked her if she knew how he got the cut on his hand. She stated she bit him when his arm was around her neck and he was on her back. I asked if she felt like she was being choked or if she was going to lose consciousness, but she stated she did not. He pulled her to the ground using his arm around her neck. She began yelling for the juvenile to help her.

I spoke with the reporting party, the mother and neighbor of the victim. She stated she received a phone call from the juvenile and could hear the victim crying in the background. The reporting party got off the phone with the juvenile and called the police.

The offender was transported to VCCC and booked on the listed charge.
