These messages stated Betsy was being held against her will and demanded that Stephen cashapp \$50 to a cashapp account for Betsy's release. The messages also told Stephen that if he went to the police they would kill Betsy. Officers attempted to ping Betsy's phone and made multiple attempts through various avenues to locate her to check her welfare. At this time Betsy has not been located.
