reenter her home to retrieve her cellphone. The reporter stated the offender retrieved a piece of broken glass and swung it at her causing her to fear she would be hurt. The reporter demonstrated the swing in a stabbing motion.

The offender was searched incident to arrest. Two broken glass smoking devices with burnt residue were located on his person along with shards of broken glass with residue indicating the devices were broken recently, assumedly during the incident. Due to our training and experience, we recognized these devices with residue were used to introduce a controlled substance into the body. The broken glass smoking devices were photographed and disposed of. A Crime Scene Detective responded to the scene to photograph the damage.

The offender was transported to Deaconess Midtown Hospital for jail medical clearance. The offender was transported to the Vanderburgh County Confinement Center where he was booked and processed for the above listed charges.

We also received a return indicating the registered owner had an active misdemeanor warrant. We initiated a traffic stop in the area of Washington Ave and Parrett St.

We approached the vehicle and came into contact with driver and registered owner, and her front seat passenger. We confirmed the driver was the registered owner. I observed a green leafy substance sitting on a blue tray alongside a roach in the center console. Due to my training and experience, I recognized the green leafy substance as marijuana. Both occupants were asked to step out of the vehicle and detained in handcuffs. I conducted a probable cause search of the vehicle.

I located a green leafy substance wrapped in tobacco between the passenger seat and the passenger door. I located a blue resealable bag containing burnt remainders of a green leafy substance wrapped in tobacco in the driver's black bag. I located a purple resealable bag and an orange resealable bag containing a green leafy substance in the same black bag. I located one half of a pink pill and 1 green pill inscribed with "Gucci" in an orange/white resealable bag inside the driver's gray bag. I collected the green leafy substance and two roaches from the blue tray in the center console.
