Through officers training and experience the burnt residue on the foil, the cut straw and the burnt residue on the currency was used to ingest narcotics.</p> <p>The two light colored rocks, burnt residue on the foil and burnt residue on the currency tested postive for fentanyl. The two lightly colored rocks had a field weight of .64 grams and the burnt residue in the foil had a field weight of 1.64 grams. Savannah was transported to VCCC for booking. IO1 was released from the scene.</p> <p>While officers were processing Savannah`s property at VCCC they located more narcotics. Prior to locating the narcotics Savannah was asked on scene and before the booking process began if she had any other narcotics in her possession and she stated she did not.
