The offender stated the victim was there, but she had walked off after throwing a bottle at him. The offender stated he did not know how the victim sustained her injuries. The other male's present were uncooperative and stated they had been asleep during the supposed altercation.	
		I provided the victim the associated case number, domestic violence victim's rights forms, and a list of social services which may be of benefit to her. I advised the victim on how to file for a protective order and she was released on scene.
