I turned around to follow the vehicle. I entered the vehicle's license plate information into the Indiana Bureau of Motor Vehicle's database upon which I observed the registered owner's drivers status was suspended with prior conviction. I followed behind and paced the vehicle at 40 miles per hour eastbound on Covert Ave from Kentucky Ave in the posted 30 mile per hour zone. I initiated a traffic stop at the intersection of Covert Ave and Gilbert Ave.</p> <p>I approached the vehicle and came into contact with the registered owner and sole occupant. I asked the driver if she knew why I stopped the vehicle to which she replied she knew her driver's license is suspended. I recognized the odor of marijuana emanating from the vehicle. I asked the driver when marijuana was last smoked in the vehicle to which she replied "Yesterday." I advised the driver to step out of the vehicle and wait at the front of my vehicle while I conducted a probable cause search. I read the driver her Miranda Rights which she stated she understood.</p> <p>I located three burnt remainders of a green leafy substance wrapped in tobacco in the center console. I located a small white perforated strip of paper wrapped in paper in the glovebox. I placed both items into evidence bags. Due to my training and experience, I recognized the white perforated strip of paper as LSD.</p> <p>I asked the driver if she had ever used LSD. The driver stated she had and she had forgot about the LSD in the vehicle. I showed the driver the white perforated paper wrapped in paper and she confirmed it was LSD.</p> <p>I issued the driver misdemeanor citations for operating a motor vehicle while suspended with prior conviction, possession of marijuana, and possession of a non-narcotic schedule I controlled substance with the attached court date and time. The driver was instructed to park her vehicle in a nearby private lot and released on scene.
