I placed these items into evidence bags. The front right passenger was read her Miranda Right which she stated she understood. I asked the passenger if she had used the makeshift smoking device to smoke crack cocaine which she confirmed.</p> <p>I issued the driver a misdemeanor citation for possession of marijuana with the attached court date and time. I issued the passenger a misdemeanor citation for possession of marijuana and possession of paraphernalia with the attached court date and time. All parties and their vehicle were released on scene.</p> <p>I field tested the green leafy substances with Duquenois-Levine Reagent test which yielded positive results for THC.
