The driver stated she did not possess her ID and provided me a false name and date of birth. I confirmed the passenger's identity via her local RMS image and confirmed via the image of the name provided; the driver had provided a false name.</p> <p>I asked the driver to identify a second time and was provided the same name with a different date of birth. I advised the driver to provide me her real name which she provided. I detained the driver in doublelocked handcuffs. I entered the driver's name and date of birth into the Indiana Bureau of Motor Vehicles database upon which I observed her status of suspended infraction on a regular ID card.</p> <p>I read the driver her Miranda Rights which she stated she understood. I asked the driver if she had ever obtained a driver's license to which she stated she had not. The passenger and the vehicle were released on scene. I transported the driver to the Vanderburgh County Confinement Center where she was booked and processed for operating without ever obtaining a license and false reporting/false informing.</p>		PAPE, N.
