The front seat passenger provided a false name. I determined the passenger's identity and observed he had an active felony warrant and an active misdemeanor warrant. A white powdery substance later field testing positive for heroin and producing a field weight of 4.1 grams. A green leafy substance and a green leafy substance wrapped in tobacco which both later field tested positive for THC and produced a combined field weight of 4 grams.
