I arrived and contacted Caleb Townsend (victim 1) and Lindsey Nuckols (victim 2). They stated their vehicle was just sideswiped by another vehicle. They pointed at a parked Silver Ford Fusion (Indiana PE PERYUPH) and identified it as the vehicle that hit their car. They stated the driver had returned to the vehicle and was in the driver seat. I asked them to gather information for an accident report and I would return to them momentarily.

I approached the driver side of the Ford Fusion and contacted Derek Perry (offender). His speech was very slurred, but I could understand that he stated he hit her door. I could see that Perry urinated on himself. I asked Perry to step out of the vehicle so we could talk on the sidewalk. He agreed and pulled himself out of the vehicle using his driver door. Perry's balance was very poor as we walked around the front of his vehicle to the sidewalk. He used his vehicle to maintain his balance before I assisted him in sitting down on the sidewalk. I read Perry his Miranda Warning and he would not give me a response so I told him I had to take a non-response as he was not willing to talk. I believed Perry to be under the influence of alcohol so I placed him in handcuffs.

I returned to Caleb and Lindsey and got their side of the story. They just returned home with their 3 juvenile children (victims 3,4,5). Caleb parallel parked their vehicle in front of the house (facing southbound). Caleb opened the door in preparation to exit the vehicle. Perry, driving southbound, hit the open-door causing damage to Caleb and Lindsey's vehicle. Perry pulled down the street a few houses, parked, and exited his vehicle. When he exited his vehicle, he fell down in the roadway. Lindsey, Caleb, and the children were in the vehicle when the crash occurred. I gave them a case number for the accident and incident report.

Detectives K. Dennis and J. McCrarey were standing with Perry while I spoke to Caleb and Lindsey. Dennis called Perry an ambulance because he stated he was a diabetic. The fire department responded with AMR. EFD arrived first and began checking Perry's vitals. A firefighter that was close to Perry's head mentioned the odor of alcoholic beverages emitting from Perry. AMR checked Perry's blood sugar and it returned normal (according to them) at 108. Perry was transported, by AMR, to Deaconess Midtown Hospital. Perry's behavior, at the hospital, became very abusive. He was hateful with the emergency room staff and cussed out nearly every hospital employee that came to do their job.

I read Perry Indiana Implied Consent and he denied a chemical test.

A few X-ray technicians came to Perry's room to administer an X-ray. Perry was very uncooperative and would not listen to simple commands. Mariah Schwoeppe, one of the X-ray technicians, needed to lower Perry's pants for his X-ray (because he would not let them remove his belt). Several nurses had to be called in to hold his arms and legs down so he would not hit or kick anyone. Perry grabbed Mariah on her left forearm. He squeezed very hard, using his fingernails, and would not let go after being asked. Perry let go of Mariah's arm after a few moments. Mariah had redness and marks on her arm. Perry sat up in hospital bed. He looked at me and told me that he would shoot me. I have no reason to believe that Perry wouldn't follow through with his threat because I have not had prior dealings with him. Kaley Oliver, Perry's nurse, witnessed the whole incident. The marks/redness, on Mariah, were documented with my Body Worn body camera.
