Officer VanFleet and I arrived and made contact with the caller. He was later identified as Caleb Mayes (witness). He told us the problem individuals were inside the house. I made contact with a male that lives at the residence, but was not involved in the situation. I asked him if there was anybody inside the house and he said no. I called into the home and made contact with Kaelyn James. I asked Kaelyn if we could step out back and talk. She agreed and we went to the backyard. I asked her what was going on today. She said we've been fighting. I asked her who has been fighting and she said Micheal (Bairos). I asked her if it had gotten physical between the two of them and she said yes. She said they had an argument about a car and him being gone all day. Michael and Kaelyn have a child in common.

I made contact with Michael and had him step outside (front door). He had a bruise under his left eye. The bruise looked like it recently happened. Michael confirmed they got into an argument about him being gone. I asked Michael what happened to his eye. He said that she did it "way earlier today".

I returned to Kaelyn and read her Miranda Warning. She stated she understood and was willing to talk. I asked her what happened to his eye. She said "I hit him back." I asked her if their child witnessed this at all and she said no. Both Kaelyn and Michael were placed in handcuffs.

I spoke with Caleb. I asked if the altercation took place in front of the 1 year old juvenile child. He stated it did. Caleb said he woke up and heard her screaming help. He stays in the basement so he had to go up the stairs and by the time he made it to the kitchen he could see Micheal with his hand on Kaelyn's chest. Michael was holding her down and punching her in the leg. Caleb said he did not see her punch him in the face, but he referenced the bruise under his left eye. Caleb said this is a constant occurrence between Kaelyn and Michael.

Kaelyn and Micheal were transported to VCCC and booked on the listed charge.
