Officers told the male to take his hands out of his pockets and turn around. The male then placed both his arms in front of him near his chest and began to tense up when officers grabbed him. Officers were able to place the male into handcuffs without incident.</p> <p>Officers then conducted a search incident to arrest of his person. While conducting a search officers located a glass jar with a plastic bag containing a white crystalline substance in his front left pocket. The substance later tested positive for methamphetamine with a field weight 1.87 grams. Officers also located a white bottle containing a green leafy substance. The green leafy substance later tested positive for marijuana with a field weight of less than one gram.</p> <p>The male was later transported to Deaconess Midtown for jail clearance. After receiving jail clearance the male was transported to VCCC. While at the jail officers were searching his property that was in male's pockets during the search incident to arrest. Officers located a black cloth sunglasses case that contained a clear plastic straw that contained a white residue along with a clear plastic bag that contained a green gummy with marking "KP."
