On 04/07/2025, Officers and I were dispatched to 1100 W Florida St in reference to a report of an assault in progress. The victim advised Dispatch she had been pepper sprayed and threatened with a bat.

I arrived and observed redness and skin irritation to the victim's left eye and left ear which was consistent with having been pepper sprayed. I was advised the offender was in the bathroom.

I knocked at the bathroom door and instructed the offender to exit. The offender emerged holding a canister of pepper spray. The offender was detained and the pepper spray collected as evidence. The offender was read her Miranda Rights which she stated she understood.

The offender stated she had been upset with the victim and had thrown water at her. The offender stated the victim threatened her and she had pepper sprayed the victim.

The victim and a witness stated the offender had raised a metal bat over her shoulder in a batting stance and appeared as if she would swing the bat at the victim. The bat was collected as evidence.

The offender was transported to the Vanderburgh County Confinement Center where she was booked and processed for intimidation with a deadly weapon and battery. The baseball bat and pepper spray were deposited at EPD headquarters.
