> Officers were dispatched to an arson in progress in the area of Henning Ave. and Monroe Ave. for a detached structure fire. Dispatched stated the reporter told them that a male fled through an alley and they think he is the one who set a fire to the garage. The reporter told dispatch it was a white male wearing a grey shirt and blue jeans. The reporter stated the fire was getting larger and she could see it from

> When I, Officer A. Davis arrived, I located smoke in the area of Monroe Ave. and Henning Ave. I quickly located a small fire along the southwest corner of a garage in the back of 1301 Henning Ave. I immediately made contact with the reporter, who was able to describe the male to me and show me video footage. The male appeared to show up in the video frame walking east on Monroe Ave. from S Harlan Ave. The male appeared to be white, wearing jeans, a grey shirt, and carrying a large gas can.

> I observed the male in the footage walk up to the garage, raise the gas can and dump a liquid from the gas can along the top west side of the garage along the length of the garage going to the south. Several seconds later, I observed the entire video footage glow as the garage was set fire to. While there was a large fire glowing, you can see the male reenter the video, dump a gas can inside a trash can and flee west on Monroe Ave., back towards S Harlan. What I observed in the video is the same statement the reporter/witness provided me with.

> Officers were able to make contact with the homeowner, who stated he currently rents the residence and has only lived there for a month. The resident and reporter were both given case numbers for an arson report. The reporter was also informed a detective may contact her to obtain the video footage. The reporter also stated she believes the gentlemen who set the fire looked familiar. She described him being short and stocky, around 5'8 with a short buzz cut haircut. She stated he looks like a male she sees around approximately 1500 hundred hours or later always on a small black electric scooter. She stated the male fled the fire running the exact same way she sees the male riding the scooter he looks like. I informed the reporter, if she happens to see the male to contact dispatch, so we can attempt to locate the male.

I was able to locate the gas can inside the trash can. Crime scene was contacted and came to the scene to process the scene and collect the gas can. I also obtained pictures using my body worn camera. Evansville Fire Department arrived quickly and extinguished the fire. EFD fire investigator arrived on scene and began processing the scene. I provided the fire investigator with a case number and explained to him what I was informed by the witness and that I did locate a gas can that was used by the suspect as an accelerator.
